## Case Narrative

**OFFENSE:** Assault by Contact, Class C & Disorderly Conduct, Profanity, Class C

**OFFICER:** A. Matthews

**ASSIGNMENT:** On Friday, 05/13/05 at 1332 hours Officer A. Matthews #105 was dispatched 411 ESE Loop 323 Tyler in reference to an Assault that occurred in C & D Unit hallway.

**SCENE SUMMARY:** Address is 411 ESE Loop 323, Tyler, TX 75703, a TISD property located within the Tyler, Smith County Texas.

**SYNOPSIS:** R/o Matthews was contacted by Officer Andrew Whitfield in reference to an Assault that had occurred in the C & D Unit hallway. Officer Whitfield advised that we needed to meet with Assistant Principal Virginia Davis in her office. Upon arrival R/o Matthews was directed by Mrs. Davis secretary Becky Rivas to the classroom next to her office where a student was being treated by the school Nurse Mary Wyatt' for injuries he had received dispute with a teacher. The student was identified asXXXX . R/o Matthews observed a long deep scratch mark on the underside of XXXX left arm. The cut was fresh and bleeding. The cut appeared right under the end of XXXX sleeve on his T-shirt. Nurse Mary was cleaning and doctoring the wound. XXXX stated that earlier he and 2 other students had been sitting on a bench outside Mr. Ted Kamel's classroom during lunch break. XXXX advised that Mr.Kamel had exited his classroom and advised XXXX and the other two students that they were not allowed to sit on the bench and needed to move on. XXXX advised that he told Mr.Kamel that it was lunch time and they could sit on the bench if they liked. XXXX stated that Mr.Kamel went back inside his classroom and was standing with his back against the classroom door. XXXX stated as he got up to leave he banged on the door with both hands and began walking off. XXXXX stated that Mr. Kamel came flying out of the classroom yelling at him and using profanity towards him. XXXX stated me Kamel attempted to grab him by the neck as he exited the classroom, but XXXX was able to duck from him. XXXX stated Mr.Kamel became aggressive towards him and began pushing and grabbing at him. XXXX stated he pulled away from Mr.Kamel several times, but that Mr.Kamel kept coming at him. XXXX stated that Mr.Kamel was saying things like "he was tired of this shit" "fuck this shit" and "God damn kids". XXXX stated Mr.Kamel was dragging him by his shirt and arm down the hallway and continued to scream. XXXX stated several teachers stopped teaching and came into the hallway to observed what was taking place. XXXX stated Mr.Kamel arrived in Mrs. Davis office with XXXX and continued to use profanity and scream in XXXX face. XXXX stated he screamed at Becky Rivas to give him an

infraction. XXXX stated as Mr.Kamel filled out the infraction he broke the tip of his pen off and ink splattered everywhere. At one point a student inside Mr. Rivas office asked Mr.Kamel to refrain from using the vulgar language and Mr.Kamel ignored and continued to use the profanity in front of everyone in the office. XXXX stated that Mr.Kamel stormed out the office. XXXX stated Mr.Kamel returned a 2<sup>nd</sup> time yelling once more for Rivas to call the police and have XXXX issued a citation. XXXX gave a written statement as to what had occurred.

R/o Matthews met with Secretary Becky Rivas in regards to the incident. Mrs. Rivas appeared shaken up and upset from the incident. Mrs. Rivas stated that she was very terrified and was scared for XXXX safety. Mrs.Rivas advised she had never seen Mr.Kamel act that way Mrs. Rivas stated that Mr.Kamel appeared to act as if he was going to strike XXXX. Mrs. Rivas stated that she heard the profanity and argument down the hall and left her desk to see what was going on. Mrs. Rivas thought a fight may have broken out in the hallway. Mrs. Rivas advised she could not get out the door to look due to students were standing in the doorway. Becky gave a written statement as to what she and observed.

R/o Matthews met with Mrs. Johnston a teacher located in the hallway. Ms. Johnston stated that she had heard the commotion and assumed a fight was occurring in the hallway. Mrs. Johnston stated she closed and locked her classroom door and it wasn't until a student began frantically knocking on her door that she opened it back up. The student advised Mrs. Johnston that a teacher was assaulting a student. Mrs. Johnston advised she could hear Mr.Kamel yelling he was tired of this shit and dragging a student to the office. Mrs. Johnston gave a written statement.

R/o Matthews met with several students who were in the hallway or Mrs. Rivas office at the time of the incident. The following witnesses were identified as XXXX, ; XXXX, XXXX; Stephan Arterberry, B/M. All were present during the verbal and physical altercation at some point. All witnesses gave statements to Officer Matthews.

R/o Matthews along with Officer Andrew Whitfield and Assistant Principals Falzone and Davis went to Mr.Kamel's classroom, located in C1 04. R/o Matthews asked Mr.Kamel to step outside. Mr.Kamel stepped outside. R/o Matthews asked Mr.Kamel what had taken place with XXXX earlier that day. Mr.Kamel stated that XXXX had been sitting outside on the bench with several other students during lunch aggravating his class. Mr.Kamel stated he stepped outside the door and asked the students to move on. Mr.Kamel stated that when he closed the classroom door back, he leaned up against it with his back. Mr.Kamel stated that XXXX threw his body against causing the class to break out in laughter. Mr.Kamel stated he did not physically see XXXX throw his body against the door, but assumed because of the noises on the door. Mr.Kamel stated he was very upset and exited the classroom yelling at XXXX. Mr.Kamel did admit that he grabbed XXXX several times pulling him to the office. R/o Matthews asked Mr.Kamel did he ever use profanity towards XXXX and he stated that he could not remember and that he was so upset that when adults are upset they may say something they shouldn't. Mr.Kamel gave R/o Matthews and Officer Whitfield a written statement.

R/o Matthews believes that Ted Kamel intentionally and knowingly made physical contact with XXXX, knowing that XXXX would regard the contact as offensive. R/o Matthews also believes that Ted Kamel committed the offense

of Disorderly Conduct Profaner language, by using words such as shit, god damn, fuck, and mother fucker, in a public place, Robert E. Lee High School, that would cause a immediate breech of peace.

**NARRATIVE:**

On May 13, 2005 officers were contacted by a staff member of a confrontation between a teacher and a student that occurred on the campus of Robert E Lee High School located at 411 ESE Loop 323 Tyler, Smith County, Texas.

Officer Whitfield received a call from Becky Rivas, assistant to Mrs. Virginia Davis –Assistant Principal. The call consisted of there has been a problem between XXXX , a student at Robert E Lee, and a teacher Ted Kamel. She advised that officers needed to respond to Mrs. Davis' office immediately.

After I hung the phone up I advised officer Matthews of the phone call and both officers responded to the call. Upon arrival officer Whitfield spoke with Mrs. Rivas and she advised that XXXX was next door with the school nurse. Officer Whitfield and Matthews went next door and observed the school nurse Mary Wyatt giving care to XXXX and cleaning up an injury to his left arm. The injury to the arm appeared to be scratches with one predominant scratch approximately three inches long. Mr. Kamel was not present when officers arrived and had already returned to the classroom.

Officers spoke to XXXX and asked what had happened. He advised that his friends and himself were sitting on the bench in front of C103 during lunch when Mr. Kamel advised the group that they could not sit there it was against rules. XXXX told Mr. Kamel that they could sit there and that they were not disrupting his class. Mr. Kamel then asked again and went back inside the classroom with his back to the door facing into the classroom. He advised the door was ajar with Mr. Kamel against it, when XXXX tapped the door twice as he walked by and continued walking toward the "D" unit on campus. XXXX then advised that Mr. Kamel came out of the class

room and stated "I'm tired of this shit" and went to grab XXXX, in doing so he grabbed his neck and shirt and began to drag XXXX toward Mrs. Davis' office. Mr. Kamel continued to use multiple choices of profane language from the class room until the incident finally ended in the principal's office. XXXX advised he was able to get released from Mr. Kamel once when he continued to grab and forcefully move XXXX from outside in the courtyard area to Mrs. Davis' office located inside the "D" unit. He advised that Mr. Kamel was grabbing at anything he could to get control of him.

XXXX advised that numerous students and teachers stopped what they were doing and directed their attention toward the incident taking place and observed the actions of both parties involved.

Speaking to multiple students all volunteered to provide written statements for officers in regards to this incident. Staff members also that witnessed all or part of the incident were also asked and volunteered to write statements in reference to this incident. All available witnesses were spoken to by officers and statements collected before the end of the school day. Mrs. Rivas did advised officer Whitfield that she was scared for [REDACTED] in regards to that she never had seen Mr. Kamel like this and thought that Mr. Kamel was actually going to strike or hurt XXXX if officers did not respond and help diffuse the incident.

Officers after beginning the investigation and receiving initial reports, contacted Chief Jimmy Mount and Principal Rick McDaniel to notify them of the incident in order for them to take action if needed.

Officer Whitfield requested that Mr. Kamel stop by the police office on campus to fill out a written statement of the incident if he would volunteer. Mr. Kamel did stop by the office while talking to his attorney on the cell phone. After speaking with his attorney he provided officers with a written statement of the incident voluntarily.
