MANY DID NOT, AND THE CURRENT COUNCIL INCUMBENT SCOTT PRESCHER, REFERRED AS ("INCUMBENT"). SIGNS WERE IMPROPERLY PLACED AND THE CITY DID NOT TAKE STEPS FOR REMOVAL, AS RECORDS IN CITY HALL WILL REFLECT PRIOR REMOVAL OF SIGNS DURING A PREVIOUS ELECTION.



CODE OF FAIR CAMPAIGN PRACTICES

There are basic principles of decency, honesty, and fair play that every candidate and political committee in this state has a moral obligation to observe and uphold, in order that, after vigorously contested but fairly conducted campaigns, our citizens may exercise their constitutional rights to a free and untrammelled choice and the will of the people may be fully and clearly expressed on the issues.

THEREFORE:

- (1) I will conduct the campaign openly and publicly and limit attacks on my opponent to legitimate challenges to my opponent's record and stated positions on issues.
- (2) I will not use or permit the use of character defamation, whispering campaigns, libel, slander, or scurrilous attacks on any candidate or the candidate's personal or family life.
- (3) I will not use or permit any appeal to negative prejudice based on race, sex, religion, or national origin.
- (4) I will not use campaign material of any sort that misrepresents, distorts, or otherwise falsifies the facts, nor will I use malicious or unfounded accusations that aim at creating or exploiting doubts, without justification, as to the personal integrity or patriotism of my opponent.
- (5) I will not undertake or condone any dishonest or unethical practice that tends to corrupt or undermine our system of free elections or that hampers or prevents the full and free expression of the will of the voters, including any activity aimed at intimidating voters or discouraging them from voting.
- (6) I will defend and uphold the right of every qualified voter to full and equal participation in the electoral process, and will not engage in any activity aimed at intimidating voters or discouraging them from voting.
- (7) I will immediately and publicly repudiate methods and tactics that may come from others that I have pledged not to use or condone. I shall take firm action against any subordinate who violates any provision of this code or the laws governing elections.

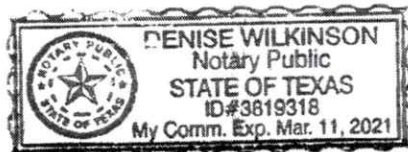

Series of Communications now Illegal!

- Post Doyle in 2019 - The criminal provision in Texas Government Code Section 551.143(a) now reads that it is an offense if a councilmember:
 1. knowingly engages in at least one communication among a series of communications that
 - a. each occur outside of a meeting authorized by this chapter and
 - b. that concern an issue within the jurisdiction of the governmental body in which the members engaging in the individual communications constitute fewer than a quorum of members but
 - c. the members engaging in the series of communications constitute a quorum of members; and
 - d. knew at the time the member engaged in the communication that the series of communications:
 - i. involved or would involve a quorum; and
 - ii. would constitute a deliberation once a quorum of members engaged in the series of communications.
- A violation of Section 551.143 is punishable by a fine of not less than \$100 or more than \$500, confinement in the county jail for not less than one month or more than six months, or both.

Overview

The Watauga Crime Control and Prevention District was created by referendum of the citizens of Watauga in March of 1996, renewed in May of 2001 and renewed again in November 2010 for a period of 10 years.. The District was designed in compliance with the Texas Local Government Code, Title 11, Subtitle C, Chapter 363.

The Watauga Crime Control and Prevention District provides for the establishing of a ½ cent sales tax for the express purpose of funding of crime control programs, including the costs of personnel, expansion administration, enhancement and capital expenditures. The specific types of programs are listed in sub-chapter D of Chapter 363.161.

The district is governed by seven members of the Board of Directors. The Board are responsible for budgeting, managing, controlling and administering district funds.

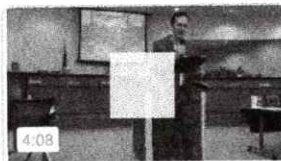

Thank you for your submittal in Civic Plus and the opportunity to address your concerns. I will begin with some information about mixed-use developments and the impacts such developments have on communities. Typically, mixed-use developments are a combination of residential and non-residential buildings that are planned and developed within a city. The real estate projects can range from a single building to an entire neighborhood and are typically developed to be responsive to a specific environment. Mixed-use development projects aim to offer a variety of benefits that include walkability between housing in the City, workplaces, and other amenities. Mixed-use development also tends to require a more proficient management service company in order to address the diverse needs of the entire community.

The specific development being proposed has been presented as a multi-type residential living infused with light commercial/retail style development that is planned in accordance with the vision set by the City in 2016. The residential component has been presented as two styles of residential development, with one being a high-quality market rate Class A apartment living targeting young professionals just starting out and unable to afford homeownership to the elder population no longer able to properly maintain a home due to physical ability or health. Rising student loan burdens are often placing homeownership just out of reach for many younger households that have plans to establish an independent household once able to afford the down payment required for homeownership. There are times when it makes more financial or quality of life sense to rent. The other style of residential living is also expected to appeal to young professionals ready for the next step just before homeownership to the aging population that prefers to maintain independence like single family living but without the responsibilities that come with homeownership. The overall goal is to create a Watauga Town Center style development considering the proximity it will share to City facilities to include the Capp Smith Park and the Library. The development proposes to utilize high quality building materials as required by the City code and will include 6' lighted sidewalks along public rights of way and other amenities expected for a quality development. This type of development will complement the City area and the area along Hightower Drive well.

The City's Comprehensive Plan adopted on April 25, 2016 on pages 54-56 address Mixed Use Sites. The Plan breaks the City into zones, with Zone 2 being along Hightower Drive and calls out this Zone as an ideal location for medium-density attached residential product and zero-lot-line single family residential, as well as a small strip of retail along Hightower Drive.

According to the National Association of Realtors (NAR), first time homebuyers made up 32 percent of all homebuyers in 2015, with nearly 67 percent of those buyers being millennials (ages 18-34 years old). A primary trait sought by Millennial homebuyers is walkability. A 2015 NAR survey revealed that millennials prefer walking as a mode of transportation by 12 percentage points over driving. Today's homebuyer has a strong

preference for central locations with easy access to city amenities. Furthermore, Fannie Mae data reveals that about half of current renters under the age of 35 are currently renting to prepare themselves financially to purchase a home.

The developer of the proposed mixed-use development hasn't proposed to include Section 8 or Affordable Housing of any type in the proposed Planned Development. In fact, the apartments proposed for Hightower Commons will be market rate apartments with high quality finishes and amenities that allow the property to rent for top of the market rates. The proposed first phase includes 201 apartments consisting of 47% as 1 bedroom/ 1 bath apartments with a rent range from \$995 - \$1,200/month, 49% as 2 bedroom/2 bath apartments renting from \$1,400 - \$1,600/month and 4% as 3 bedroom/3 bath apartments renting from \$1,750/month. The rates provided are base rate rents that can also include premium charges for location, views, size of patio/balcony, etc. Each household must be qualified for residence in the property and complete a thorough application through the developer's third-party management partner. Residents will be required to show proof of income 3 times the monthly rental amount and complete a credit and rental history that ensure the character and quality of the community is maintained. I encourage you to correct the misinformation and attend the public hearings scheduled for August 7, August 20 and August 27 to hear the details of the planned development before formulating your opinion about such development.

If Watauga isn't willing to provide consumer choice options for those that find homeownership just out of reach by supplying quality multifamily housing options, those forced renters may decide on homeownership elsewhere when they are ready.

City Council

Meetings

Watauga City Council Regular Meetings are approved a year in advance by City Council and are **generally** scheduled on the last Monday of each month. When approving the Regular Meeting schedule, City Council takes into consideration various factors such as holidays and Charter provisions. Special City Council Meetings are called as needed and notice of all meetings can be found on the required bulletin boards at City Hall. Regular City Council Meetings and Special City Council Meetings are held at City Hall in the City Council Chamber located at 7105 Whitley Road, Watauga, Texas 76148. All agendas are also posted on-line in compliance with the Texas Open Meetings Act and are available for you to view at your convenience. City Council approved the most recent version of their Council Rules of Procedure Manual on August 5, 2019.

Form of Government

Watauga is led by a Mayor/Council/City Manager form of government, with the Mayor and all seven (7) City Council seats elected at-large for a two year term. Direct citizen input to City government takes the form of several volunteer boards, commissions and committees, which advise the City Council on a variety of issues such as crime prevention, parks, recreation and community services, etc.

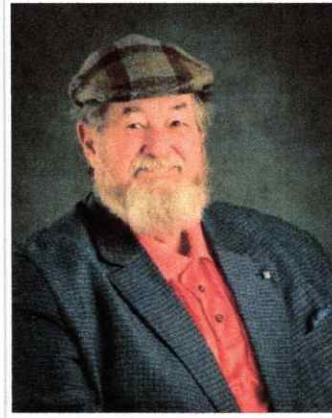

Overview

The Watauga Crime Control and Prevention District was created by referendum of the citizens of Watauga in March of 1996, renewed in May of 2001 and renewed again in November 2010 for a period of 10 years.. The District was designed in compliance with the Texas Local Government Code, Title 11, Subtitle C, Chapter 363.

The Watauga Crime Control and Prevention District provides for the establishing of a ½ cent sales tax for the express purpose of funding of crime control programs, including the costs of personnel, expansion administration, enhancement and capital expenditures. The specific types of programs are listed in sub-chapter D of Chapter 363.161.

The district is governed by seven members of the Board of Directors. The Board are responsible for budgeting, managing, controlling and administering district funds.

Youth Advisory Council

Meetings

The Youth Advisory Council meets as needed. The five (5) members must be enrolled and attending classes in 8th, 9th, 10th, 11th or 12th grade at the time of appointment. Additionally, each member must meet at least one of the following qualifications:

1. Reside in the City of Watauga
2. Reside within the boundaries of Birdville Independent School District or the Keller Independent School District
3. Attend a state recognized school or home school within the City of Watauga

Members are appointed by the City Council.

Each member of Youth Advisory Council shall serve for a one-year term and may be reappointed for consecutive terms, provided such member meets the qualification requirements set forth above.

“Our reaction spoke volumes,” said Jennifer Cooper, who helped organize the opposition. “We weren’t going to give up.”

Another resident, Lindsey Neal, said she helped create a Facebook group, [Say No to Rezoning in Watauga](#), which quickly grew to nearly 1,000 members in less than three weeks.

“This blind-sided us,” she said. “People need to pay attention. Now I hope we will have a new generation of people who will participate.”

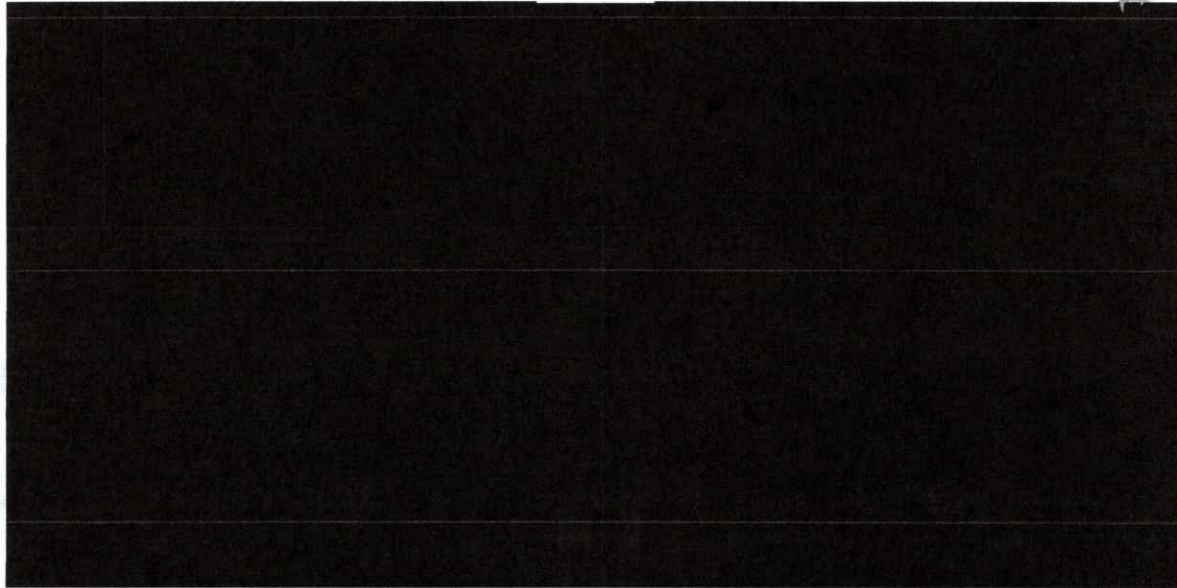

Councilwoman Sandra Bush said Watauga has a history of fighting back.

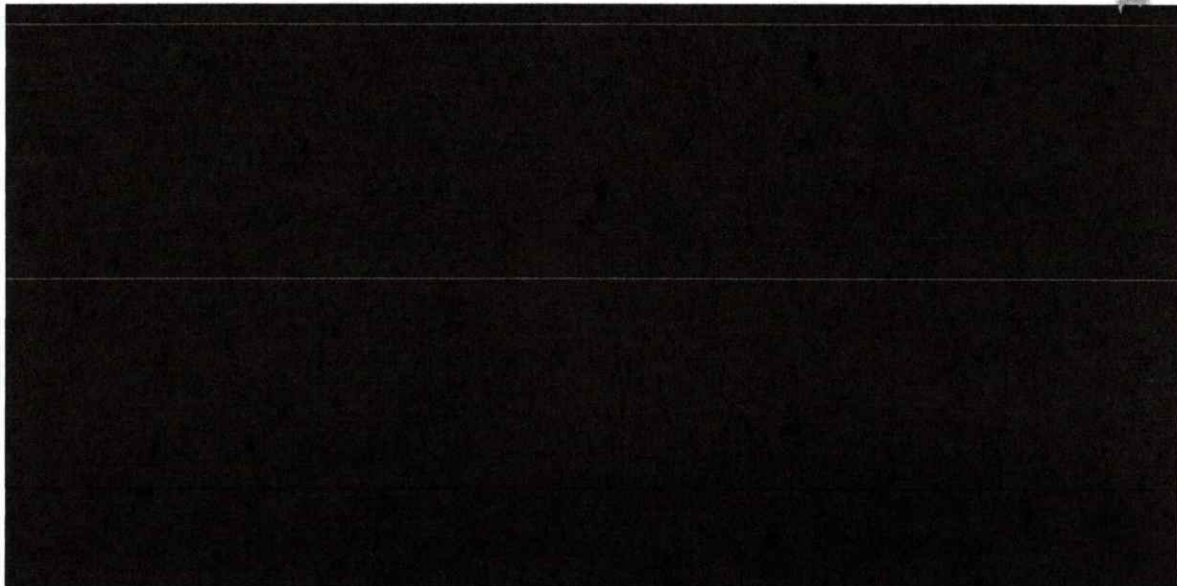
"People come here because they refer to it as a residential city," she said. "They want to maintain that because they like the fact that it is a little paradise in the middle of a giant Metroplex."
