FYI issue with TMD 1) Server they were using for SFTP was not whitelisted with CPA to use 2) TMD did not know what account to use 3) CPA IT had to give TMD access to the correct directory for their account 4) TMD incorrectly placed the file in the wrong directory they were using the "Out" folder instead of the "In" folder 4) TMD with our assistance successfully placed the file in the correct location with help from CAPPS IT and CPA IT assistance but the file was named correctly but done without encryption. We will work with TMD to get the encryption applied correctly going forward


