I am requesting to NOT be removed from the cases as requested by Philip Wischkaemper. It is not my responsibility to find my clients and make them appear at court. I have done my due diligence: I gave them my two cell phone phone numbers, two EZ texting numbers, and we provided them with the court date on their bond documents.

I am requesting a hearing on the matter of my removal from any and all LPDO appointed cases.

Attached is a copy of the State Bar Grievance I just filed against Philip Wischkaemper for ordering me to NOT abide by my clients' wishes when they desire to plead guilty. He directed me and all the OLS defense counsel to refuse to plead our clients guilty even if they are guilty and even if it is their desire (and it is) to plead guilty.

I consulted with the State Bar Ethics Helpline Attorney who advised me to file a grievance and then I could go public with my complaints. Philip is acting in a retaliatory fashion against me in this and many other instances because I plead five clients guilty. Honoring his request to remove me would only result in further undue delay.

Dear All:

We are s I o w I y receiving names of attorneys who have been appointed to represent inmates arrested for criminal trespass/mischief in Kinney County.

Out of the 251 cases on file in county court, only 40 have attorneys appointed to represent them. We are receiving a few notices from Ms Muro but it's 2-4 appointments per day. (More cases have been approved by the County Attorney but due to workload, our clerk can only file a few each day.) My concern is that we are not receiving notices from your organizations or the attys themselves of who has been appointed to set dockets 20 days out. We now have 3 judges to hold hearings for these 750 plus inmates but as of today only 40 can be scheduled b/c only 40 have attys that we know of. Our clerk receives notices occasionally from an atty who emails an appearance notice but it's s I o w!

We are making every effort to streamline our process (software, 2 court coordinators, assistant county clerk, hardware, etc.) but need to know who represents who! This is emailed to you for your help and advice as we want to get our cases heard asap.
