Pastor Beard:

The following is a summary of the process to have an voter initiated ordinance brought before the Abilene City Council:

- (1) Section 31, City Charter, provides that the voters of Abilene have the power to propose any non-taxing ordinance to the City Council. It is called an Initiative. A petition must be signed by *qualified* voters of Abilene in a number which is at least ten percent (10%) of *qualified* voters as of the last municipal election. The last municipal election was May 2021. The City Secretary can get the required number for the petition.
- (2) Section 36, City Charter, provides that an Initiative petition must contain the *full text* of the proposed ordinance. All the signatures must be compiled into a single petition to be filed with the City Secretary as one instrument. The petition filed must contain an affidavit signed by the person filing the Initiative petition which states the number of signatures, and a statement that all signatures are, in his/her belief, genuine signatures of the purported persons. The names and addresses of the signers must be printed adjacent to the signatures.
- (3) Section 37, City Charter, provides that the City Secretary shall determine, within 20 days of filing, whether a sufficient number of qualified voters have signed and whether a proper affidavit is attached. If approved, the City Secretary shall certify the result at the next Council meeting. If the petition is insufficient, the City Secretary will state in his/her certificate the reasons why the petition is defective, and notify the person who filed the Initiative petition. If defective, an initiative petition may be amended within ten (10) days after the notice of insufficiency is sent (Section 38, City Charter).
- (4) Section 39, City Charter, provides that the City Council must take final action on the certified Initiative within thirty (30) days after it is submitted to the Council. The proposed Ordinance will be read in a public meeting and there will be a public hearing.
- (5) Section 40, City Charter, provides that if the City Council does not pass the Initiative ordinance in the exact form proposed, the Initiative ordinance will be submitted to the voters. If a majority of voters vote in favor of the proposed ordinance, it becomes an ordinance of the city.

As you know, I am the attorney for the City of Abilene, and I cannot assist you in this initiative process. The above information is the process as set-out in the City Charter. My suggestion is that you consult with someone, whether an attorney or otherwise, who can assist you in details of this process.
