#### TO THE HONORABLE TEXAS SUPREME COURT:

Shortly after the last filing in this case, multiple presiding judges have come forward to report that Harris County employees have approached presiding judges with a "letter" from Respondent directing them to deliver election records to the central counting station. Those county employees have insisted that they have been deputized to transport those records and argued with Presiding Judges who are reluctant to turn over their ballots. Some of the county employees have been Harris County constables, whose status as law enforcement officers cloak their demands with improper authority.

Respondent's letter states that the "Presiding Judge will also designate you to deliver election records and supplies to the Central Counting Station and administer an oath before providing the records and supplies to you." See Exhibit A (emphasis added). In other words, the letter does not give the Presiding Judge a choice about whether to permit county employees to deliver ballots. This directly contradicts Respondent's earlier representation to the Court that those services would be purely voluntary and at the discretion of the election judges.

Respondent's conduct violates Texas Election Code §§ 66.051-66.052 and causes confusion among volunteer election judges regarding their responsibilities under Texas law. Respondent has no authority to deputize county employees or instruct that presiding judges "will" use county employees to transport ballots.

Respondent is attempting to interfere with this Court's ability to issue a decision in this case by giving improper and illegal instructions. Respondent is asking this Court to dismiss Relators' Petition for Writ of Mandamus as moot while violating Texas law and trying to obstruct this Court from issuing a decision in accordance with Texas law.
