\* Two cities recanted their ordinances. (02) The Omaha, TX City Council repealed their ordinance in exchange for a non-binding resolution October 14th, 2019. They did so upon the advice of their City Attorney after the ACLU filed an open records request. Omaha is the only city to have recanted their ordinance after being intimidated by the ACLU's open records request. (41) The Mason, OH City Council repealed their ordinance on December 13th, 2021 after new leadership, openly against the ordinance, were elected to the Mason City Council in the November 2nd, 2021 election.
