Okay, welcome to episode 150 of the Lugman CES show. We are here to tell you if you didn't already know that in Texas vaccine mandates are alive and well. And that comes in various different forms and fashions. This isn't one vaccine mandate, this isn't to vaccine mandates. This is a bunch of vaccine mandates, all of which are alive and well in Texas. Even though a vast majority of Republican voters don't believe there should be vaccine mandates. They don't believe that employers should be able to fire patriots who had been unvaccinated. They do not believe that the government should be able to fire they don't think the government should be able to force businesses hand on having employees vaccinated or unvaccinated. But they also don't believe that these corporations can come in privately and just say, Hey, we're going to be the heavy hand of the government coordinated through Biden requesting that we bow to His will or Fauci telling us this is what you have to do. And now these corporations come in and go, Well, we're going to fire everybody who's not vaccinated for the government and the ruling elites that have decided this is what we need to do. And we have to cast out all of those people who have thought for themselves and made their own medical decisions. That is the current situation that we're under. And those mandates are alive and well in Texas this morning. Brian Harrison said OSHA vaccine mandates goes into effect today, nation wide. And in Texas, why in the world? Are we not fighting this tyranny with every tool available? And that is the question that a lot of us are asking, why are we not fighting this with every single tool available to Texans? I don't know. Here's the scary thing. There's a chance that the Supreme Court does away with the OSHA mandate, there is a chance, but here's what you need to understand. Even if they do. There are still vaccine mandates in Texas. They still exist. They're still here. Texans are still going to lose their jobs. Well, how Luke if OSHA goes away, because they're not all firing people because of OSHA, they've been firing people before OSHA, and they're gonna file paper people after OSHA, because Texas has let them fire people. There's only about a dozen Republican states who have actually gone out there and said, No, you cannot fire people because they haven't taken the COVID vaccine, period. End of story, protect those citizens. A dozen Republican states is Texas one of those No. I can promise you if they do try to do something, every Republican politician is going to come out and say Texas is going to lead on this. But we're not we might be blessed to follow 1314 1211 other states. I've seen the list a couple different times and asked I don't keep up with it because all I know is Texas hasn't I get

sent different lists these states have done at the states haven't Oh, this state is now added to the list. That's great. All I know is Texas hasn't done it. Citizens for renewing America and organization led by Russ Vought Wade Miller, who has been a activist here in Texas for a very long time really respected, worked at the Heritage. Heritage auction for a little while. A lot of grassroots Texans in this state, no way. But he then went to work for Congressman chip Roy, and he now works at Citizens for renewing America, which is one of the organizations who has been started by former Trump administration officials to advance an America First agenda, and citizens for undoing. America put out a call just two hours ago, two hours after the recording of this podcast, which it'll go this podcast will be aired tomorrow. So let's say 24 hours ago at this point, but they put out and the headline was Texas must convene a fourth special session immediately. And this has been the same call by the Texas GOP. The Texas GOP for months has been saying we need a fourth special session to address the vaccine mandates in Texas that are going on and will continue to go on until we pass a bill addressing the issue. So citizens for renewing America's at Texas must convene a fourth special session immediately. COVID vaccine mandates are intrusive unethical and should be made illegal in every instance, American lives are being up ended through the mass firings making it hard to provide for themselves and their family. American lives are being upended through mass firings making it hard to provide for themselves and their families further efforts at the national and state level. To require vaccine passports to travel, go to a restaurant or enter places of business amplify the already significant violation of individual liberties and medical privacy. This that is occurring across America. Therefore we call on Governor Greg Abbott to immediately call for a fourth special session of the Texas Legislature to consider legislation like the Texas COVID vaccine Freedom Act, HB 168 authored by State Representative Brian Harrison, which would put an end to all forms of government, governmental and private sector COVID vaccine mandates and that's the point That what some of your elected politicians that are trying to ignore the issue, Greg Abbott being one of them is saying, Oh, well, I'm I'm suing, I'm in federal court. I'm suing. And what he's saying is some of the mandates I'm suing against. So stop telling me to address mandates, because there are some of the mandates that I'm against, and I'm taking action in the courts, and I'm waiting. Every single week there are Texans, they get fired from their job for not being vaccinated, and no one's fighting for them. You can't say, Well, I filed a brief at the United States Supreme Court. What am I going to do tomorrow when I'm fired? I filed a brief what you could have called a special session three months ago, we could have passed a bill, we could have actually made it and we've covered this issue before on the podcast. Governor Abbott put the vaccine mandate issue on the special session with like a week to go in the special session on a week and a half to go. He knew it was gonna die. Steve Toth. Representative Toth said he knew it was going to die out of the woodlands. He said Hey, he put this on when he knew was going to die. If he wanted it, he we'd come back for a fourth special session, which is the same reason the Texas GOP has asked for a fourth special session. But we're not getting it. It was back in December 17th that the OSHA mandates were reinstated. As soon as a court struck it down. You saw all the political class Sharon, victory and court victory. We've got it. We've taken down the Biden administration. Couple weeks later, when it gets overturned and they get reinstated. They're gonna go into effect. You didn't see all those same Republican politicians posting saying the facts have changed. Now we need to do something about it. No, because they don't want to have to do anything about it. Even if the Supreme Court rules against OSHA, we still have to stop vaccine mandates in Texas, it's the number one thing you have to understand. We can't get away from it. If we want to protect citizens in Texas, we're gonna have to actually act. You should see if your state representative has even done anything on this issue. How have they have you contacted your Republican state rep and said, hey, where do you stand on vaccine mandates and walk and a fourth special session, here's what you have to understand. Every single Republican out there is going to tell you they're against vaccine mandates, because they know they have to to get reelected. But that

doesn't mean they're doing anything. There's specific things that could or couldn't be done. But if you were somebody who wanted that to happen, the thing that would have to occur would be for a for special session to be called so that legislation could happen. That's what you would have to that's how you would address the issue. You should ask your Republican lawmaker, where do you stand on it? Heck, if somebody is knocking on your door running for county commissioner, you should ask him where they talk, where they stand on it, because Republicans for a long time just don't want to address these issues at all. Moving on from vaccine mandates, we'll close today. And we've got a couple of conversations, by the way, coming to you in the next couple of weeks, which I think you'll really enjoy. A lot of people have had different candidates reaching out to us, I'll just tell you, we've you know, tried to kind of discuss looking to see a show the possibility of having different people who are running for office on the show. And it's something we're still open to. And I know many of you have sent our show to candidates you're supporting because they reach out to us and they say, Hey, I'm running for Senate or House or Congress or whatever, we'd love to come on your show, or these supporters of mine have listened to your show, please. Could you come on. And there's a lot of requirements, I just wanted to kind of let y'all know, listeners since this is something you're continuing to do. But because of some regulations, and you know, we the Luke Misia show is sponsored by Texas scorecard. And Texas scorecard is a 501 C three. So it does not specifically advocate for or against an election in particular. And so as a result, you know, we have one candidate on we now have to offer invitations to other candidates on the issues and things like that. And so these are things that we have to weigh and things that we need to consider in the process of deciding what, what campaigns to have a conversation with, if that makes sense. Because now there's regulations on who we do and don't have to talk to, so we have to really consider that. And I just wanted to make sure that you our listeners and viewers kind of got that update. As as you were made aware, because we are in the middle of a campaign cycle. And I know a lot of you know that I have a background having worked on a lot of campaigns and done a lot of campaigns. But on this show specifically we keep it focused on issues and what's going on. Now these things I mean, information when it's put out there has a massive impact on people's opinions on where things are going. But we do have some restrictions and we just want to make sure that you our listeners and viewers know that so I want to close today and talking about what was confirmed by the Dallas Morning News last week, which was originally reported by Michael Quinn Sullivan here at Texas scorecard which is that CPS the Department of Family Protective Services stopped the critical race theory. instructional material that they were mandating their employees take and this was done after Don Hofheinz campaign came out and and criticized, Governor Abbott and his state agency in his agency heads for requiring that their employees basically take critical race theory mandated reading materials and training and videos to view and then actually answer a quiz on that material where they have to affirm that they agree with it, that they understand that white supremacy is bad, and that white privilege is bad and that Texas has been built on these racist ideas. And we need to do away with that system. And there's all sorts of craziness. We talked about this a little bit on the show already before, but it's just something for you to be aware of that this was something that was mandated for state employees. So people go, you know, I had an eye appointment today, and I will not name my optometrists. But you know, I went in and he was a Republican. And so we're sitting there talking, I don't want him to get canceled. But we're talking about the different issues that are going on today. And he says, Man, are these California is going to turn Texas blue? And I told them, absolutely not. They're not going to turn Texas blue. Most of them are Republicans, their political refugees come in to keep the state red. And he said, Well, I'm, I'm glad and I said, but the problem is, I will tell you this. I mean, Texas is turning our own people blue. We are paying to turn our own people blue, we are giving universities I mean, Governor Abbott has come out before and said, Hey, I want to give universities even more money than we're already given them, give them billions more. These

are the same universities, they're having drag shows that have their LGBTQIA el LMNOP study groups that are funding all sorts of radical left ideas that are indoctrinating their students. Those are the universities that we're giving pay raises to. We know, there's indoctrination going on in K through 12. Public Schools, we're not only doing that we're even requiring 1000s and 1000s of state employees being paid for directly by your state taxpayer dollars.
