EXORD 225-21 COVID-19 Steady State Operations

1. In accordance with Department of Defense Instructions and Army Regulations, I formally request an exemption from the COVID-19 vaccine because of my religious beliefs.

2. I, [REDACTED] Crystal, invoke my exemption from all vaccines based on my sincerely-held religious belief. I will not be inoculated with any vaccine(s) because it violates God's Law.

I am a Roman Catholic who believes in God, Jesus as the Son of God, the Bible inspired word of God, and also calling on Mary and other saints to intercede on their behalf.

Dr. Stanley Plotkin, MD Jan 11, 2018 Deposition under oath study

During his testimony, Dr. Plotkin was asked how many fetuses were related to his work in vaccines to which he confidently answered "two." However when Attorney Aaron Siri gave Dr. Plotkin a copy of his own study citing his early work at the Wistar Institute, the doctor was forced to admit that in just one study, out of several conducted, he used the tissues of "76 fetuses." Wherein the same study these fetuses were all 3 months or older normally developed fetuses. For, government, university, or industrial scientists to use materials obtained from the remains of an electively aborted child in the testing, research, development, or production of any vaccine is immoral and constitutes formal cooperation in evil. I must never cease to disapprove this practice with maximum determination to defend the dignity and sacredness of children in the womb. They are persons to be received as gifts, our brothers and sisters, not objects to be used.

If my sincere request is not approved, it will impose a great burden. I will remain faithful to the truth concerning the dignity of every human life and mobilize my consciences in favor of life. I testify to the truth that abortion must be rejected and make a choice that is consistent with the dignity of every human life from conception to natural death and is rooted in a mature faith and trust in eternal life, not fear of suffering in this life. I have the responsibility to make an informed and moral choice as to the use of particular vaccines.

The Church teaches: "Conscience must be informed and moral judgment enlightened. A well-formed conscience is upright and truthful. It formulates its judgments according to reason, in conformity with the true good willed by the wisdom of the Creator" (Catechism of the Catholic Church 1783). My conscience is formed in accordance with what is true as revealed in natural law and divine revelation and to act accordingly when deciding about the use of vaccines.
