Dear Robert Montoya,

In response to your request for records of all doctors, physicians, and/or medical practitioners investigated and penalized for prescribing ivermectin, hydroxychloroquine, and/or inhaled budesonide, Please see below and attached:

Stella G. Immanuel, M.D.- On October 15, 2021, the Board and Stella G. Immanuel, M.D., entered a non-disciplinary Remedial Plan that requires Dr. Immanuel to within one month update and submit a copy of her informed consent document, for all off-label treatments she provides, to the Compliance Division of the Board and adopt policies and procedures to require that all consent documents are reviewed with and signed by patients prior to any off-label treatment being initiated; and within 60 days pay an administrative fee of \$500 per year. The Board found Dr. Immanuel failed to give adequate informed consent to one patient for the prescription of hydroxychloroquine for treatment. Dr. Immanuel does not admit or deny the findings but agreed to the remedial plan to avoid the cost and uncertainty of litigation.

Ivette C. Lozano, M.D.- On December 10, 2021, the Board and Ivette C. Lozano, M.D., entered into a Mediated Agreed Order requiring Dr. Lozano to within 30 days submit informed consent forms to the Board for review, and upon review and approval, shall be required to present the form to each and every patient receiving medical care or being evaluated at her practice; and within one year complete at least eight hours of CME, divided as follows: four hours in medical records and four hours in informed consent. The Board found Dr. Lozano failed to meet Board Rule 200 requirements for two patients she treated for COVID-19 with complementary and alternative medicine. The order resolves a formal complaint at the State Office of Administrative Hearings.
