To Whom It May Concern:

This letter is written on behalf of the Plano Independent School District (“District”) in response to a request for public information dated and received on October 27, 2022, from Erin Anderson with Texas Score Card (“Requestor”).

The District is seeking an Attorney General’s opinion regarding Requestor’s request for the following information (the “Request”):

1. *“Purchase orders and/or payment receipts documenting expenses related to marketing the 2022 Bond and VATRE: consulting services, mailers (including postage), printed materials, signage, video, online messaging, robocalls.”*

A copy of Requestor’s written request is attached as **Exhibit “A.”** According to the interpretations by the Attorney General, the District has ten (10) business days to respond to Requestor’s request. Therefore, the District’s request is timely filed.

The District asserts that documents responsive to Requestor’s request are excepted from disclosure, in their entirety, under the following exceptions to the Public Information Act: Section 552.101 through Section 552.162.
