I write to request your consideration in withdrawing or otherwise not adopting the above referenced proposed rules regarding Texas Tax Code Chapter 313 transparency and reporting requirements.

As Chair of the Senate Committee on Natural Resources and Economic Development, I continue to dedicate significant time and effort towards securing and improving transparency measures on behalf of both my constituents and Texans as a whole. While I understand and support the need for efficient and conservative government practices in our agencies, I must also stress the consistent need for taxpayers to have readily available access to information surrounding Chapter 313 agreements. As the program approaches the expiration date of December 31, 2022, reporting requirements and the accompanying details, as well as the central hosting of these details with the Comptroller's office, remain crucial. Among the reasons this data remains important are the long length and significant fiscal implications of these agreements, as well as the valuable information they can provide for statistical and programmatic analysis for future legislatures. The current transparency measures and accompanying information are not only useful to legislators and stakeholders, but remain crucial to Texas taxpayers that deserve to readily trace each dollar associated with these agreements.
