Your guide to insurance, retirement, time & leave, and other non-pay compensation

Working at DFPS earns you many benefits beyond your paycheck. Most of these - like insurance and vacation - are managed through either the Employees Retirement System (ERS) or CAPPS.

About Benefits Enrollment

You may select your benefits—including your health insurance, optional coverage and 401k plan—during your initial "enrollment period". Your optional coverage will begin upon hire and your medical insurance will have a 60 day waiting period. You will have 31 days from hire to make changes to your optional coverage and 60 days to make changes to your health coverage. Any changes thereafter, may be made due to a qualifying life event (QLE) or during ERS' annual "open enrollment" period, which is usually during the summer months.

Health Insurance

Full-time and part-time employees are eligible to enroll in health insurance. If you are a full-time employee, you can select health insurance through HealthSelect (Blue Cross Blue Shield of Texas), Consumer Directed Health Select or a regional HMO (health maintenance organization) within certain regions of Texas. 100% of the premium is paid for by the state for employee's coverage and 50% is paid for your dependent's coverage. If you are a part-time employee, you can enroll in the same coverage as a full-time employee. 50% of the premium is paid for by the state for employee's coverage and 25% is paid for your dependent's coverage.

All of our health plans offer discount plans on prescription drug coverage. HealthSelect members use OptumRX and each HMO includes a comprehensive prescription drug coverage administered by the HMO directly. [learn more]

Dental Insurance

You have two dental plans to choose from, both of which are offered by Delta Dental. Learn more on this ERS Dental Comparison Chart.

Vision Insurance

Some vision benefits are built into your medical and dental coverage. However, we now offer a separate Vision insurance administered by Superior Vision.

Life and Other Insurance

When you sign up for health coverage, you get a \$5,000 basic

Retirement

Depending on your age and how long you have worked, you may receive an annuity (monthly check) and other benefits when you retire.



However, it is only one part of a financially secure retirement. Learn more at Benefits at-a Glance/Retirement and Active-Employees/Retirement.

You can speed your way to retirement by applying or purchasing certain types of prior public employment or military service.

You contribute 9.5% of your gross monthly salary, and the state contributes 9.5%.

An employee is eligible to receive one month of service credit for each 160 hours or fraction of 160 hours of unused sick leave and vacation leave credited to them at the time of the employee's retirement. This service credit may be used to:

- satisfy requirements for retirement,
- satisfy requirements for group insurance eligibility, or
- increase the employee's annuity benefit.

Exception: If the employee was hired on or after September 1, 2009; or was a former state employee rehired on or after September 1, 2009 and previously withdrew his or her ERS retirement contributions, the employee cannot use unused sick leave and vacation leave to satisfy requirements for

With TexFlex, flexible spending accounts (FSA) let you set aside money from your check, pre-tax, to use for eligible out-of-pocket



expenses including: health care, dependent day care, commuting expenses, and dental and vision expenses. The more you spend, the more you save.

Be aware that you cannot withdraw the money as cash; you must spend the money within a specified period of time; and only certain products and services are eligible. [learn more]

In addition to the flexible spending accounts, there is a health savings account (HSA) option for employees enrolled in the Consumer Directed Health-Select insurance coverage. The Public Service Loan Forgiveness (PSLF) program allows for forgiveness of student loans for full-time employees of public service agencies, including child or family protective service agencies. The loans that are eligible include:


