Dear Mr. Gordon:

On June 20, 2023, the Texas Department of Transportation (TxDOT) received a Public Information Act request from Soli Rice requesting communications in the possession of the Texas Department of Transportation Commissioner; the Chief of Staff; the Director of Human Resources; and/or the Director of the Diversity, Equity and Inclusion Section referencing DEI, ESG, diversity, equity, inclusion, environmental, social, and/or governance from May 15, 2023, to May 22, 2023.

The request is enclosed as **Exhibit A**, and in accordance with section 552.301 of the Government Code, TxDOT is seeking a ruling on the request. TxDOT's request for a ruling is timely under section 552.301(b) because it is made within 10-business days from the date the open records request was received.

TxDOT asserts that the requested information may be excepted from disclosure under the Public Information Act. Specifically, TxDOT invokes all of the exceptions provided by, and the exceptions incorporated into, sections 552.101 through 552.158 of the Government Code.

Pursuant to section 552.301(a) of the Government Code, this letter is submitted to seek a decision whether the exceptions apply. To assist in your review, TxDOT will provide the excepted information and a brief of written comments in support of these exceptions. The brief and information will be submitted not later than the 15th business day from the date the request was received.

In accordance with section 552.301(d)(1) of the Government Code, TxDOT has notified the requestor that it wishes to withhold the excepted information and is seeking an attorney general ruling. TxDOT has also sent a copy of this letter to the requestor in accordance with section 552.301(d)(2).
