
Plaintiffs acknowledge receipt of the Judgment amount and that it has been fully satisfied and paid.



NOW COMES Denton Independent School District, Jamie Wilson and Barbara Fischer, Defendants in the above-styled and numbered cause (hereinafter collectively "School Defendants"), and present this their Offer of Judgment pursuant to Rule 68 of the Federal Rules of Civil Procedure in the amount of \$150,000.00 (ONE HUNDRED FIFTY THOUSAND DOLLARS). This lump-sum amount encompasses any and all items of damages, attorney's fees and costs. This offer of judgment is made in exchange for a settlement and release of all claims by Plaintiffs Jane Doe, Dennis Mason and Linda Mason against the School Defendants and any and all officers, agents and employees of the Denton Independent School District, except for Michael Pricer, arising from the incident(s) and Plaintiffs' alleged injuries made the basis of this litigation.

This offer of judgment is made for the purposes specified in Federal Rule of Civil Procedure 68, and is not to be construed either as an admission of liability on the part of the School Defendants, or any and all officers, agents and employees of Denton Independent School District, or as an admission that Plaintiffs have sustained any injury or damage, or as an admission that Plaintiffs are entitled to any recovery.

Pursuant to the provisions of Federal Rule of Civil Procedure 68, if this offer of judgment is not accepted within fourteen (14) days of receipt, and any judgment finally obtained by Plaintiffs against the School Defendants is not more favorable than this unaccepted offer, the Plaintiffs shall be obligated to pay the costs incurred after the offer was made.
