IN THE NAME AND BY AUTHORITY OF THE STATE OF TEXAS:

Before me, the undersigned Assistant District Attorney of Harris County, Texas, this day appeared the undersigned affiant, who under oath says that he has good reason to believe and does believe that in Harris County, Texas, **CHRISTOPHER WAYNE WILLIAMS**, hereafter styled the Defendant, heretofore on or about **October 16, 2023**, did then and there unlawfully, while an employee of a public secondary school, intentionally and knowingly engage in sexual contact with K.R., hereinafter called the Complainant, a student who was enrolled at the school at which the Defendant worked and who was not the Defendant's spouse, by causing the penetration of the Complainant's female sexual organ with the Defendant's finger.

Probable Cause

AFFIANT, R. D RODRIGUEZ, IS A CERTIFIED PEACE OFFICER EMPLOYED WITH HOUSTON ISD POLICE DEPARTMENT. AFFIANT HAS REASONS TO BELIEVE AND DOES BELIEVE THAT CHRISTOPHER WAYNE WILLIAMS, DATE OF BIRTH OF JUNE 26, 1982, HEREINAFTER DEFENDANT, COMMITTED THE FELONY OFFENSE OF IMPROPER RELATIONSHIP BETWEEN EDUCATOR AND STUDENT, IN HARRIS COUNTY TEXAS ON OR ABOUT OCTOBER 16, 2023.

AFFIANT'S BELIEF IS BASED ON THE FOLLOWING FACTS:

AFFIANT IS A PEACE OFFICER ASSIGNED TO EASTWOOD ACADEMY, A PUBLIC HIGH SCHOOL IN THE HOUSTON INDEPENDENT SCHOOL DISTRICT. AFFIANT SPOKE TO THE REPORTEE, A STUDENT AT EASTWOOD ACADEMY, WHO AFFIANT BELIEVES TO BE CREDIBLE AND RELIABLE. REPORTEE STATED TO AFFIANT THAT HER FRIEND, K.R., HEREAFTER CALLED COMPLAINANT, HAD CONFIDED IN HER THAT SHE AND "MR. WILLIAMS," WHO REPORTEE IDENTIFIED AS A TEACHER AT EASTWOOD ACADEMY, WOULD KISS AND HUG EACH OTHER IN HIS CLASSROOM ON CAMPUS. REPORTEE IDENTIFIED THE TEACHER WHO WAS ALLEGEDLY ENGAGING IN THE INAPPROPRIATE RELATIONSHIP AS CHRISTOPHER WILLIAMS, HEREAFTER IDENTIFIED AS DEFENDANT. AFFIANT VERIFIED THAT DEFENDANT WAS A U.S. HISTORY AND DEBATE TEACHER AT EASTWOOD ACADEMY AND THAT HE HAD BEEN A TEACHER AT EASTWOOD SINCE SCHOOL YEAR 2017-2018. AFFIANT ALSO VERIFIED THAT COMPLAINANT WAS A STUDENT AT EASTWOOD ACADEMY BY HER STUDENT ID NUMBER AND THAT SHE WAS IN DEFENDANT'S DEBATE CLASS DURING THE 2023-2024 SCHOOL YEAR. AFFIANT VERIFIED THAT DEFENDANT IS THE ONLY MR. WILLIAMS WHO WAS WORKING AT EASTWOOD ACADEMY AT THE TIME OF THE OFFENSE AND THE ONLY CHRISTOPHER WILLIAMS EMPLOYED AT EASTWOOD ACADEMY. DEFENDANT WAS POSITIVELY IDENTIFIED AS CHRISTOPHER WAYNE WILLIAMS (DOB: 06/26/1982) VIA TEXAS DRIVER'S LICENSE PHOTO# 17705892. AFFIANT OBSERVED THAT THE DATE OF BIRTH FOR DEFENDANT IS THE SAME DOB ON THE DRIVERS LICENSE AS IN HIS EMPLOYEE RECORDS AND THAT HIS EMPLOYEE RECORDS ACTUALLY CONTAIN A COPY OF HIS DRIVERS LICENSE AND AFFIANT WAS ABLE TO DETERMINE THAT THE DRIVERS LICENSE OBTAINED BY AFFIANT IS THE SAME ONE THAT IS COPIED IN HIS EASTWOOD ACADEMY EMPLOYMENT RECORDS.

ON OR ABOUT OCTOBER 25, 2023, AFFIANT INTERVIEWED COMPLAINANT ABOUT THE RELATIONSHIP BETWEEN HER AND THE DEFENDANT. DURING THIS INTERVIEW, THE COMPLAINANT DENIED HAVING ANY RELATIONSHIP WITH THE DEFENDANT. AFFIANT THEN ASKED THE COMPLAINANT TO CONSENT TO SEARCH HER CELLPHONE FOR ANY EVIDENCE. COMPLAINANT AGREED AND SIGNED A CONSENT TO SEARCH FORM. AFFIANT ALSO NOTIFIED COMPLAINANT'S PARENTS ABOUT THE ALLEGED RELATIONSHIP. ON OR ABOUT OCTOBER 26, 2023, AFFIANT RECEIVED A PHONE CALL FROM THE COMPLAINANT'S FATHER WHO TOLD AFFIANT THAT COMPLAINANT WAS NOW

WILLING TO DISCUSS HER RELATIONSHIP WITH THE DEFENDANT.

ON OCTOBER 25, 2023, AFFIANT SPOKE TO C.M. A CREDIBLE AND RELIABLE PERSON EMPLOYED DURING THE SUMMER OF 2023 AS TEACHER AT EASTWOOD ACADEMY AND AN ORIENTATION COORDINATOR FOR THE SCHOOL'S BOXER CAMP FOR INCOMING FRESHMAN. C.M. TOLD AFFIANT THAT IN AUGUST OF 2023 SHE HAD BEEN APPROACHED BY SEVERAL STUDENTS REGARDING CONCERNING INTERACTIONS BETWEEN COMPLAINANT AND DEFENDANT, WHO C.M. KNEW BY NAME AND SIGHT AS A TEACHER AT EASTWOOD. C.M. STATED THAT SHE REPORTED HER CONCERNS TO THE SCHOOL PRINCIPAL THAT DEFENDANT AND THE COMPLAINANT SEEMED TO BE UNUSUALLY CLOSE. C.M. TOLD AFFIANT THAT SHE DISCUSSED THE SITUATION WITH ANOTHER TEACHER WHO EXPRESSED SIMILAR CONCERNS.


ON OCTOBER 26, 2023, AFFIANT INTERVIEWED THE COMPLAINANT AGAIN AT EASTWOOD ACADEMY HIGH SCHOOL. THE COMPLAINANT STATED TO AFFIANT THAT SHE HAD LIED PREVIOUSLY AND THAT SHE HAD FEELINGS FOR THE DEFENDANT SINCE NOVEMBER OF 2022. COMPLAINANT TOLD AFFIANT THAT SHE AND THE DEFENDANT WOULD EVENTUALLY BEGIN TO MEET IN HIS CLASSROOM AT EASTWOOD ACADEMY DURING SCHOOL AND THEY WOULD KISS AND HUG EACH OTHER. COMPLAINANT ALSO TOLD AFFIANT THAT THE RELATIONSHIP GREW INTO MEETING FOR LUNCH BY THEMSELVES IN HIS CLASSROOM NUMEROUS TIMES. AFFIANT THEN ASKED THE COMPLAINANT IF THE DEFENDANT EVER TOUCHED HER PRIVATE PARTS AND COMPLAINANT STATED THAT THE DEFENDANT HAD PUT HIS HAND UNDERNEATH HER PANTS AND INSERTED HIS FINGERS IN HER "COOTER". COMPLAINANT EXPLAINED FOR AFFIANT THAT HER "COOTER" WAS A NAME FOR HER VAGINA. COMPLAINANT STATED THAT THIS OCCURRED WHILE IN HIS CLASSROOM AT EASTWOOD ACADEMY, ON OR ABOUT OCTOBER 16, 2023. AFFIANT IS ASSIGNED TO EASTWOOD ACADEMY AND KNOWS THAT THE SCHOOL IS LOCATED WITHIN HARRIS COUNTY, TEXAS. COMPLAINANT STATED THAT SHE HAD GOTTEN SCARED BECAUSE SHE WAS BLEEDING AFTER THE DEFENDANT HAD INSERTED HIS FINGERS INSIDE HER.

ON OR ABOUT OCTOBER 26, 2023, AFFIANT TOOK THE COMPLAINANT'S CELLPHONE TO THE HARRIS COUNTY DISTRICT ATTORNEY'S DIGITAL FORENSIC UNIT FOR EVIDENCE EXTRACTION UNIT. ON OR ABOUT OCTOBER 31, 2023, AFFIANT PICKED UP THE COMPLAINANT'S CELLPHONE, ALONG WITH THE EXTRACTION REPORT FROM THE HARRIS COUNTY DISTRICT ATTORNEY'S DIGITAL FORENSIC UNIT. AFFIANT REVIEWED THE REPORT AND FOUND SEVERAL TEXT MESSAGES BETWEEN THE COMPLAINANT AND THE DEFENDANT'S CELLPHONE NUMBER OF 713-298-7526 BEGINNING ON THE DATE OF SEPTEMBER 27, 2023, ENDING ON OCTOBER 20, 2023. AFFIANT OBSERVED THAT THE TEXT MESSAGES CONTAINED MANY STATEMENTS FROM THE DEFENDANT TO THE COMPLAINANT THAT APPEARED TO BE OF A SEXUAL/ROMANTIC NATURE. COMPLAINANT IDENTIFIED THE PHONE NUMBER THAT SHE WAS MESSAGING BELONGED TO DEFENDANT. AFFIANT OBSERVED TEXTS FROM DEFENDANT TO COMPLAINANT SAYING "COMING IN LOOKING SOO (MISPELLED) FINE, BEAUTIFUL HAIR, FLAWLESS MAKEUP, SEXY FIT", "CAN'T WAIT TO KISS YOU BABY", "COME GIMME A KISS ON YOUR WAY TO LUNCH", AND MANY "I LOVE YOU" COMMENTS. AFFIANT OBSERVED A TEXT MESSAGE CONVERSATION DATED OCTOBER 16, 2023, WHERE COMPLAINANT TEXTED TO THE DEFENDANT THAT SHE WAS BLEEDING FROM HER THINGY, AND THE DEFENDANT'S RESPONSE WAS "WHAT!", "OH MY". ALSO SAW A TEXT DATED OCTOBER 17, 2023, WHERE COMPLAINANT SENT TEXT MESSAGE TO DEFENDANT SAYING THAT SHE HAD BLED AGAIN AND DEFENDANT RESPONDED BY TEXTING "OH MY, GONNA BE MORE GENTLE BABY". COMPLAINANT VERIFIED FOR AFFIANT THAT THIS TEXT CONVERSATION WAS IN REFERENCE TO THE INCIDENT WHERE DEFENDANT DIGITALLY PENETRATED HER IN HIS CLASSROOM. AFFIANT NOTED THAT THE TEXTS WERE CONSISTENT WITH THE COMPLAINANT'S STATEMENT WHICH REINFORCED AFFIANT'S BELIEF THAT COMPLAINANT WAS CREDIBLE AND RELIABLE IN HER DISCLOSURE.
