

School Choice and Lower Taxes: *Why Can't Texans Have Both?*

Texas parents want to have a choice about where their children go to school. Texas taxpayers want to stop the ever-increasing property tax burden of Texas government schools. Yet the Texas Legislature once again this year has failed to provide choice for parents and long-lasting property tax relief for taxpayers.

After the Texas Legislature failed to address school choice and the growing cost of government schools in its regular session earlier this year, Gov. Greg Abbott called the Legislature back twice this fall in special sessions to try again. Not only did members of the Legislature fail both times, but the plans they came up with put billions of taxpayer dollars more into public education than they did into school choice. Government schools never have enough of your money. Additionally, the few dollars dedicated towards school choice would be subject to annual appropriation, which will be used as leverage to hold pro-school choice members hostage.
