Charges against def: Compelling Prost x3, Trafficking Child x3. CWs are AA (juvenile), K.L 16 yo female, ED 18 yo female (17yo at DOI). Def and codef participated in managing, directing, and taking profits from three juvenile CWs in prostitution enterprise. This def knowingly transported CWs to and from motel room used for prostitution, paid for motel room, maintained Zelle account into which CWs paid proceeds from prostitution activities.
