And the Grand Jurors aforesaid, upon their oaths, do further present in and to said Court that the Defendant, on or about the 11TH DAY OF OCTOBER, 2023 and before the presentment of this indictment in the County of Kinney, State of Texas, did then and there knowingly use a motor vehicle to transport an individual, namely, Alejandro Alfaro-Tovar, with intent to conceal the individual from a peace officer,

COUNT 3:

And the Grand Jurors aforesaid, upon their oaths, do further present in and to said Court that the Defendant, on or about the 11TH DAY OF OCTOBER, 2023 and before the presentment of this indictment in the County of Kinney, State of Texas, did then and there knowingly use a motor vehicle to transport an individual, namely, Emilio Salvador Salazar-Lopez, with intent to conceal the individual from a peace officer,

COUNT 4:

And the Grand Jurors aforesaid, upon their oaths, do further present in and to said Court that the Defendant, on or about the 11TH DAY OF OCTOBER, 2023 and before the presentment of this indictment in the County of Kinney, State of Texas, did then and there knowingly use a motor vehicle to transport an individual, namely, Name Unknown, with intent to conceal the individual from a peace officer,

COUNT 5:

And the Grand Jurors aforesaid, upon their oaths, do further present in and to said Court that the Defendant, on or about the 11TH DAY OF OCTOBER, 2023 and before the presentment of this indictment in the County of Kinney, State of Texas, did then and there knowingly use a motor vehicle to transport an individual, namely, Name Unknown, with intent to conceal the individual from a peace officer,

ENHANCEMENT:

And the Grand Jurors aforesaid, upon their oaths, do further present in and to said Court that the Defendant, on or about the 11TH DAY OF OCTOBER, 2023 and before the presentment of this indictment in the County of Kinney, State of Texas, And it is further presented that, prior to the commission of the charged offense, on the 7th day of September, 2011, in cause number 2009CR11452A in the 144th District Court of Bexar County, Texas, the defendant was finally convicted of the felony offense of Aggravated Robbery.
