NOTICE OF PUBLIC HEARING ON TAX INCREASE

A tax rate of \$0.519739 per \$100 valuation has been proposed by the governing body of CITY OF WHITESBORO.

PROPOSED TAX RATE \$0.519739 per \$100 NO-NEW-REVENUE TAX RATE \$0.387645 per \$100 VOTER-APPROVAL TAX RATE \$0.499133 per \$100 DE MINIMIS RATE \$0.617003 per \$100

The no-new-revenue tax rate is the tax rate for the 2024 tax year that will raise the same amount of property tax revenue for CITY OF WHITESBORO from the same properties in both the 2023 tax year and the 2024 tax year.

The voter-approval rate is the highest tax rate that CITY OF WHITESBORO may adopt without holding an election to seek voter approval of the rate, unless the de minimis rate for CITY OF WHITESBORO exceeds the voter-approval rate for CITY OF WHITESBORO.

The de minimis rate is the rate equal to the sum of the no-new-revenue maintenance and operations rate for CITY OF WHITESBORO, the rate that will raise \$500,000, and the current debt rate for CITY OF WHITESBORO.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that CITY OF WHITESBORO is proposing to increase property taxes for the 2024 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON September 27, 2024 AT 6:00 PM AT City Hall, 111 W. Main St., Whitesboro, TX 76273.

The proposed tax rate is greater than the voter-approval tax rate but not greater than the de minimis rate and does not exceed the rate that allows voters to petition for an election under Section 26.075, Tax Code. If CITY OF WHITESBORO adopts the proposed tax rate, the CITY OF WHITESBORO is not required to hold an election so that voters may accept or reject the proposed tax rate and the qualified voters of the CITY OF WHITESBORO may not petition the CITY OF WHITESBORO to require an election to be held to determine whether to reduce the proposed tax rate.
