AGREED TEMPORARY RESTRAINING ORDER

Plaintiff Jane Doe (“Plaintiff”) and Defendant Sergio Rey in his Official Capacity as Acting Deputy Executive Director of the Texas Lottery Commission (“Rey”) hereby submit the following Agreed Temporary Restraining Order as follows. The *ex parte* Temporary Restraining Order and Order Setting Hearing for Temporary Injunction entered by the Court on June 2, 2025, is hereby vacated. It is hereby ORDERED that:

Rey and any of his agents, employees and others within his control are immediately enjoined from performing any of the following:

- a. Disbursing the \$83,500,000 jackpot prize won on February 17, 2025, to any person or entity;
- b. Wasting the \$83,500,000 jackpot prize won on February 17, 2025; and
- c. Diminishing the \$83,500,000 jackpot prize won on February 17, 2025.

Defendant does not waive any argument raised in his plea to the jurisdiction and in his response to Plaintiff’s Application for Temporary Injunction, such as sovereign immunity,

ripeness, and standing. The Court makes no final determination on the merits of the parties' respective arguments in granting this temporary restraining order.

It is further ORDERED that a temporary injunction hearing is set for Tuesday, June 10, 2025, at 2:00 p.m.

This remains effective until June 10, 2025, at 2:00 p.m., when the Court has rescheduled the hearing on Plaintiff's application for temporary injunction.



It is further ACKNOWLEDGED that Plaintiff has posted a bond in the amount of \$8,350.00.
