Dear Governor Abbott,

We, the undersigned, urge you to add legislation protecting minors from sexually explicit materials in public libraries to the call for the first special session of the 89th Legislature.

Legislation to this effect was filed in the regular session as HB 3225, which would have simply required municipal public libraries to move sexually explicit materials out of sections designated for minors and prohibit minors from checking out such materials without parental consent.

This bill was approved by the House in a 93 to 37 vote and was placed on the Senate intent calendar, but unfortunately ran out of time before it could be sent to your desk.

Under your leadership, Texas has made great strides in protecting children, especially in public spaces funded by taxpayer dollars. By adding this to the call for the special session, you will be giving the legislature another opportunity to fight the rampant sexualization of our children. For their sake, this issue should not be left waiting for another two years.

Thank you for your attention to this matter.


