PLAINTIFF'S MOTION TO REMAND

Plaintiff Jerry Reed files this Motion to Remand under Tex. R. Civ. P. 355(f) and Tex. Gov't Code § 25A.006(d).

A. INTRODUCTION

A consortium of foreign gambling companies, wealthy individuals, and domestic entities conspired to purchase nearly all 25.8 million possible number combinations in the \$95 million April 22, 2023, Texas Lotto drawing. Their calculated scheme ensured a guaranteed victory, securing the jackpot along with millions in smaller prizes.

This manipulation of the Lotto Texas drawing violated Texas criminal statutes and Texas Lottery Commission regulations. Plaintiff Jerry Reed was the rightful winner of the subsequent May 17, 2023, Lotto Texas jackpot. Had the defendants not rigged the April 22 drawing, the \$95 million prize would have rolled over and been included in his winnings.

B. ARGUMENT

Like federal courts, the newly established Texas Business Court possesses limited subject matter jurisdiction. Texas Government Code § 25A.006(d) mandates strict construction in favor of remand, stating:

[I]f the business court does not have jurisdiction of the action, the business court *shall* remand the action to the court in which the action was originally filed." (Emphasis added.)

Defendants Rook TX LP and Rook GP LLC base their removal request on the following assertion:

[Plaintiff] asserts that Rook GP LLC misrepresented the creation date of Rook TX LP to claim the April 22, 2023 prize, thus calling the entity's governing documents into question. Pet. ¶¶ 40-41. Accordingly, the business court has authority and jurisdiction over this case because it is an action regarding the governance and governing documents of an organization and the amount in controversy exceeds \$5 million. TEX. GOV'T CODE § 25A.004(b)(2); TEX. R. CIV. P. 355(b)(2)(A).

—Defendants' Notice of Removal to Business Court, p.2

Defendants' argument is fundamentally flawed. This is **not** an action regarding the governance or governing documents of Rook TX LP or Rook GP LLC. Plaintiff does not allege mismanagement, failure to comply with governance provisions, or internal violations of governing documents within these entities.

Rather, Plaintiff alleges that Defendants misrepresented the formation date of Rook TX LP when presenting the winning ticket to collect the Lotto Texas jackpot. Defendants argue that the court must examine their governing documents to determine the entity's creation date. However, such review is unnecessary.

C. THE PUBLIC RECORD ESTABLISHES MISREPRESENTATION

The falsity of Defendants' claims can be proven through publicly available records—no reference to internal governance or governing documents is required.

On June 27, 2023, New Jersey attorney Glenn Gelband, acting on behalf of Rook GP LLC, submitted a Texas Lottery Winner Claim Form (Exhibit 1), asserting that Rook TX LP was created on March 1, 2023.

However, under Delaware law, "[a] limited partnership is formed at the time of the filing of the initial certificate of limited partnership in the Office of the Secretary of State..." (Del. Code Ann. tit. 6, § 17-201(b)).

Records from the Delaware Division of Corporations confirm that Rook TX LP was **not** formed until June 15, 2023—**over seven weeks after** the April 22 Lotto Texas drawing and more than 15 weeks after the March 1, 2023, creation date falsely asserted by Gelband (Exhibit 2).

Further, Rook TX LP's general partner, Rook GP LLC, did not exist on March 1, 2023 it was incorporated on June 14, 2023, more than fifteen weeks after the date claimed by Gelband (Exhibit 3).

C. CONCLUSION

This case is **unequivocally** about a fraudulent scheme to rig the Texas Lottery and a subsequent misrepresentation made to the State of Texas. It does **not** pertain to the governance or governing documents of an organization, as Defendants argue. This matter is far beyond the scope of disputes intended for the Texas Business Court. Plaintiff respectfully urges the Court to **remand** the case to the 353rd Judicial District Court.
