

STATEMENT OF ANDREA JACKSON

On November 6, 2025, I was contacted by Virg Thomas. Virg at the time was a member of the board for Anxiety Solutions of America. He wanted me to contact him. On this call Virg asked me about the arrest of Kolton Krottinger. I informed him that Kolton's arrest had nothing to do with the non-profit. But Virg said that the non-profit would be going under the microscope in a big way. In the attached text you can also see where he said this. He also wanted to know if we had D & O insurance. I told him no. In the text you will see where I asked him what was being said.

Ongoing SO investigations, related to bookkeeping and theft. Getting the IRS involved. At this point I was curious, so I went to his office. We did not go inside, instead we went to lunch at Mi Familia. While at lunch Virg told me he had 2 contacts at the SO and these contacts were very strong and personal. That I needed to trust him.

Virg told me that the SO did not have a victim in the first investigation. I was confused. How could they open an investigation into Kolton without a victim? So, after lunch we went out to the ranch. Josh Morrison was also present. Virg kept pressing the issue of me needing to suspend Kolton from the board. But I did not like that idea. Kolton's arrest was for a personal matter, not ASA. Josh even told Virg that that was taking things a little too far. Virg sat down with Kolton and kept forcing the issue on a check that was written to Kolton for \$10,000. This check was for work he had done for this business.

Once we left the ranch, Virg kept going on about how Kolton needed to be suspended. So, I told him we could have an emergency board meeting and see what the board said.

Later when we got back to my vehicle Virg told me that I was in danger. That the SO was looking at taking me down personally. That they had enough evidence to turn into the IRS and that it would include me along with my board if I did not help them with Kolton.

Later that evening Virg texted me and said he just wanted to put my mind at ease, his contact said no more complaint about the wrongdoings on the part of the board members. Not official just through back channels.

So, on November 7, 2025, I was contacted by Virg and was told that his contact had told him about a bank account that Kolton had opened and was running. It was supposed to have had a lot of money going in and out. So, I was told that I had to go to the bank and get these bank statements to prove this.

I went to the bank and the account closed last year and the current account I acquired the statements. Then I contacted Virg and told him that I had the statements. There were a few things on there that I was not aware of.

That evening we were having an emergency board meeting. Virg said he needed to see me before the meeting. We met up at my office. I was told at that point that if the board did not suspend Kolton, so that once Kolton was out of the way, we could take it over. Once he was suspended then ASA would become the victim for the SO to pursue charges. If the board did not suspend him then they wanted me to report to the SO, the very next morning to file charges on Kolton. Saying that Kolton made me lie on documents. I was told that it was Kolton or me. I was stuck

During the board meeting I was quiet. We all looked at the statements and everything on them was justifiable. Just like every other time we have been questioned. The board sided with Kolton and decided not to suspend him. Virg immediately left the meeting.

I realized what had happened and went immediately to Kevin Andrews, commissioner and board member, and told him what I think had just happened.

Virg contacted me later, but I did not respond. I had finally realized that I was being targeted. Hood county SO was targeting me. Two days later Virg resigned from the board of Anxiety Solutions of America.

Due to this, I hated being in my office. I was terrified to even be in the parking lot. I made sure that my car was always locked. I hid every time I was there. So, due to the trauma, I closed my business.

For the first month I secluded myself in my home. I have barely got out of bed. Then I decided that the SO did not have the right to make me scared. I have stood behind Kolton since and I will always stand by Kolton. It has cost me almost everything, but I am still looking over my shoulders daily.

FORMAL STATEMENT OF ANDREA JACKSON

Date of Event: November 6–7, 2025

Subject: Activities regarding Anxiety Solutions of America (ASA) and interactions with Virg Thomas

I. Initial Contact and Allegations

On November 6, 2025, I was contacted by Virg Thomas, who served as a board member for Anxiety Solutions of America (ASA) at that time. During our initial conversation, Mr. Thomas inquired about the arrest of Kolton Krottinger. I clarified that Mr. Krottinger's arrest was a personal matter and entirely unrelated to the non-profit organization. Mr. Thomas asserted that ASA would soon be under intense scrutiny and suggested that the Sheriff's Office (SO) was conducting a more indepth investigation into the organization's bookkeeping and potential theft, involving the IRS. He further inquired whether the organization held Directors and Officers (D&O) insurance, to which I replied that we did not. These exchanges are corroborated by the attached text messages.

II. Meeting at Mi Familia and Disclosures of Influence

Later that day, I met Mr. Thomas at his office and we proceeded to lunch at Mi Familia. During this meeting, Mr. Thomas claimed to have two "very strong and personal" contacts within the Sheriff's Office. He urged me to trust his guidance. He noted that the SO currently lacked a victim for their initial investigation, which I found concerning, as I did not understand how an investigation could be initiated without a complainant.

III. Discussion at the Ranch

Following lunch, we traveled to the ranch, where Josh Morrison was also present. Mr. Thomas repeatedly pressured me to suspend Mr. Krottinger from the board. I declined, maintaining that the arrest was a private matter. Mr. Morrison also expressed that Mr. Thomas's demands were excessive. Despite this, Mr. Thomas confronted Mr. Krottinger regarding a \$10,000 check, which I knew to be legitimate compensation for contracted work performed for the Kolton's business.

IV. Coercion and Threats

Upon leaving the ranch, Mr. Thomas continued to insist on the suspension. I suggested an emergency board meeting to allow the collective board to decide. At my vehicle, Mr. Thomas's tone became exclusionary and threatening. He stated that I was in personal danger and that the SO intended to target me. He claimed they had sufficient evidence to involve the IRS and would prosecute me and the entire board unless I cooperated against Mr. Krottinger.

That evening, Mr. Thomas sent a text message attempting to "ease my mind," stating that through "back channels," his contacts indicated there would be no official complaints regarding board wrongdoing if I complied.

V. Bank Records and the Plan to Seize Control

On November 7, 2025, Mr. Thomas informed me that his contacts had identified a bank account managed by Mr. Krottinger with high-volume activity. He instructed me to obtain the statements. I discovered the account in question had been closed the previous year, but I secured the statements for the current account.

Prior to the emergency board meeting that evening, Mr. Thomas met me at my office. He outlined a strategy: if the board suspended Mr. Krottinger, we could take over the organization. He stated that once Mr. Krottinger was removed, ASA could then be positioned as the "victim," allowing the SO to pursue charges. He gave me an ultimatum: either I report to the SO the following morning to file charges against Mr. Krottinger—claiming he forced me to falsify documents—or I would be targeted myself.

VI. Board Meeting and Aftermath

During the board meeting, we reviewed the bank statements. The board determined that all transactions were justifiable and consistent with previous inquiries. The board voted against the suspension of Mr. Krottinger, at which point Mr. Thomas immediately exited the meeting.

I subsequently met with Kevin Andrews, County Commissioner and board member, to report my concerns regarding Mr. Thomas's conduct and the apparent targeting by the Hood County Sheriff's Office. Two days later, Mr. Thomas resigned from the ASA board.

VII. Impact Statement

As a result of these events, I suffered significant emotional distress and trauma. I felt unsafe in my place of business and lived in constant fear of surveillance or confrontation. This environment became untenable, forcing me to close my business. The subsequent month was marked by severe withdrawal and isolation. While I have regained the resolve to stand by the truth and support Mr. Krottinger, the professional and personal toll has been substantial. I remain vigilant and concerned for my safety.
