**IN THE NAME AND BY AUTHORITY OF THE STATE OF TEXAS:**

Before me, the undersigned Assistant District Attorney of Harris County, Texas; this day appeared the undersigned affiant, who under oath says that he has good reason to believe and does believe that in Harris County, Texas, **HAILEY HEDSPETH**, hereafter styled the Defendant, heretofore on or about **October 1, 2020 continuing through on or about January 20, 2023**, did then and there unlawfully, during a period of time of thirty or more days in duration, commit at least two acts of sexual abuse against a child younger than fourteen years of age, including an act constituting the offense of aggravated sexual assault of a child, committed against M.G. on or about October 1, 2020, and an act constituting the offense of indecency with child by contact, committed against M.G. on or about January 20, 2023, and the Defendant was at least seventeen years of age at the time of the commission of each of those acts.

**Probable Cause**

Affiant, V. Smith, employed as a certified peace officer by the Houston Police Department believes Hailey Hedspeth, a Caucasian female with date of birth September 2, 1991, hereafter styled Defendant, committed the offense of Continuous Sexual Abuse of a Child and Sexual Assault of a Child on or about October 1, 2020 through January 20, 2023 against Complainant #1 and Continuous Sexual Abuse of a Child and Sexual Assault of a Child on or about March 20, 2017 through January 20, 2023 against Complainant #2 in Harris County, Texas.

**Affiant's beliefs are based on the following facts:**

On May 28, 2025, Affiant, V. Smith, a criminal investigator in the Crimes Against Children Unit in the Special Victims Division of the Houston Police Department, was assigned Houston Police Department Case #629220-23 by Sgt. D. McCloud, for a follow up investigation.

Pursuant to her investigation, Affiant, reviewed the original incident report generated on May 14, 2025 by Senior Police Service Officer A. Austin, who is employed by the Houston Police Department, and whom Affiant finds to be credible and reliable. Officer Austin, assigned to Crimes Against Children Unit in the Special Victims Division, generated on May 4, 2023, an original police report after receiving information from the Texas Department of Family and Protective Services. Preliminary information regarding the case was originally reported to CPS Services on January 26, 2023 stating that an offense of a sexual assault of a child had occurred inside Harris County. The report stated that Complainant #1, M.G., a 15-year-old male had made an outcry of being sexually abused by their babysitter, Hailey Hedspeth, hereafter the Defendant. According to the CPS intake report, over the weekend of January 20th, 2023, Complainant #1 was observed coming out of the Defendant's room and indicated having sexual contact with the Defendant. Complainant #1 denied any sexual intercourse and oral sex, but indicated fondling. Cameras were installed in the house about a month prior and Complainant #1 was observed coming out of the Defendant's room. In the past, the Defendant had vaginal intercourse with Complainant #2, J.G., a 16-year-old male, at least two times. The complainant's mother took both children to the doctor to make sure everything was fine. The medical staff, W.F., reported the abuse to CPS. Both complainants admitted to their parents, physician, and caseworker of the sexual relationship with the Defendant.

On June 7, 2025, Affiant reviewed the CPS records and learned the caseworker stated she talked to Complainant #2 on January 31, 2023 at Complainant's school, Westside High School. Truth and lie parameters were established and Complainant #2 agreed to tell the truth. Complainant #2 stated he was 16 years old and stated that the Defendant was his babysitter and that she touched Complainant #2 inappropriately. Complainant #2 stated that it happened about 2 years ago when he was 14 years old. Complainant #2 stated that the Defendant also touched his brother, Complainant #1. Complainant #2 stated that he saw the Defendant touch Complainant #1 on his private part. Complainant #2 stated that the Defendant also touched Complainant #2 on his penis. Complainant #2 stated that he was afraid to tell anyone about the incident and stated that he had sexual intercourse with the Defendant. Complainant #2 stated that he last saw the

Defendant about a month prior. Complainant #2 stated that they had intercourse twice and the second time also occurred when he was 14 years old.

The caseworker stated she talked to Complainant #1 on January 31, 2023 at Complainant's school, Westside High School. Truth and lie parameters were established and Complainant #1 agreed to tell the truth. Complainant #1 stated he was 15 years old. Complainant #1 made a sexual abuse outcry. Complainant #1 stated his babysitter, Hailey Hedspeth, the Defendant, touched his penis about 4-6 months ago. On a follow up interview conducted on April 6, 2023 at Westside High School with Complainant #1, the caseworker asked Complainant #1 how did they get caught and Complainant #1 stated that their parents put cameras inside the house and saw when they went in & out of the Defendant's room so their parents confronted them. Complainant #1 stated they said the truth to their parents and their mother, M.B., took them to the doctor to make sure they didn't have diseases. Complainant #1 stated they were concerned the Defendant was doing this with other students because she is a teacher. Complainant #1 stated the Defendant is about 32 years old and she was friends with their mom and she became their babysitter.

The Defendant told the caseworker that she had met M.B. when the Defendant was in high school at the flower shop that M.B. owned. The Defendant stated the boys, Complainant #1 and Complainant #2, were little and she would care for them in the summer time in their home. The Defendant stated she did that all through college during the summers and graduated from Huntsville College in 2017. The Defendant stated that while she cared for the boys, she would stay over and she had her own bedroom (the guest room). The Defendant stated the last time she saw the boys was the weekend of January 20th, 2023. The Defendant denied all sexual allegations the boys made against her. When asked why would the boys say something like this about her, the Defendant stated maybe because she was sleeping with their dad.

The police investigation was inactivated because the family did not want to continue with the case, but on May 13, 2025, the Complainant's mother, M.B., contacted the Houston Police Department stating the boys were ready to continue the investigation.

On December 5, 2026, I met with M.B. at the Children's Assessment Center. M.B. stated she hired the Defendant to babysit, offered her money, trust and her house. M.B. stated that the Defendant had a room in her house to stay when she was in and out of college and would come over, baby sit, play Minecraft. M.B. stated the boys were about 4-5 years old when the Defendant began to work for the family. M.B. stated that the Defendant would stay during school breaks with the family and help babysit the boys. M.B. stated she had a conversation with the Defendant regarding the boys, around age 12-13, where she told her that she did not want her to lay with the boys anymore because they were getting bigger. M.B. stated the Defendant told her that the boys were like her brothers and the adults like her parents, to not worry. M.B. stated that one day her husband, J.C.G. approached M.B. when M.B. was in the garage and J.C.G. told M.B., "hey something is going, I heard the boys' steps exiting Hailey's room." M.B. stated she talked to the boys and without going into details, they both told her that they had sex with the Defendant since ages 12 and 13. She stated it happened many times, whenever the Defendant had a chance. M.B. stated she entered a state of shock. Ms. Bates stated she took the boys to the doctor's office. She told the doctor what happened, that the boys needed a thorough checkup because they had sex with the nanny (Defendant) and the nanny was sleeping with other men too. M.B. stated she knew the Defendant was having sex with other men because the Defendant would tell her in passing conversation. M.B. stated the Defendant told her one time they went out to celebrate their birthdays since they both have a birthday in September. M.B. stated the Defendant told her that she had sex with a stranger in the bathroom and had made some money, about \$80 or \$100. M.B. told the Defendant not to do that because she could get a sexually transmitted disease. M.B. stated the Defendant told M.B. that she already had the human papilloma virus anyway, so it didn't matter. M.B. stated her older son had the virus the Defendant carried. M.B. stated at that time, since she was in shock and did not know what to do, she left to Ecuador, and stopped the police investigation. M.B. stated while in Ecuador, the boys would tell her the Defendant would tell them, "Come cuddle with me," that they would go up to her room and have sexual contact with the Defendant. M.B. stated the boys said that the Defendant would pretend to be asleep, that they would have sex and she would get up, go to the bathroom and clean herself, so she knew what she was doing. M.B. stated the boys told her we know it's wrong and we feel bad. M.B. stated that the Defendant worked in Katy ISD with special needs kids. Ms. Bates stated her husband, J.C.G., has taken the Defendant's side and asked M.B. "why would the boys accuse someone they love?" M.B. stated that her husband said it was not wrong because they boys were adolescents. M.B. stated her husband told her in May 2025 that the Defendant was pregnant and she did not know who the father was. M.B. stated her J.C.G. proposed to his wife, M.B., adopting the Defendant's baby.

On January 22, 2026, Affiant met with Complainant #1 and Complainant #2 at the Children's Assessment Center. Complainant #1 told Affiant that the Defendant, Hailey, was his babysitter, like a big sister and has known her his whole life. Complainant #1 stated that they would play games and bake cookies. Complainant #1 stated the first time he recalls something happening was when he was 13 years old and he asked the Defendant for help to practice some lines he had to learn for theater class. Complainant #1 stated he fell asleep with the Defendant and remembers waking up in the middle of the night. Complainant #1 stated he was cuddling with the Defendant, massaging her thighs, and the Defendant kept moving around. Complainant #1 stated his hand landed on the Defendant's vagina and that opened the door to other things. Complainant #1 stated in the following months, about once a week, or occasionally, the Defendant would ask Complainant #1 to cuddle with her or massage her. Complainant #1 stated over the next months, he would go into the Defendant's room and touch her under her underwear inside her vagina. Complainant #1 told Affiant it would always start with a massage and end up with him touching the

Defendant inside her vagina with his finger. Complainant #1 stated the Defendant would take the Complainant's hand and put it on her boob, at first over her shirt and then under her shirt. Complainant #1 stated one of the last times it happened, the Defendant rubbed his penis over his clothes and he orgasmed. Complainant #1 stated he touched the Defendant once or twice after that and then his parents had a talk with him and his brother, Complainant #2 in the garage. Complainant #1 stated he never saw the Defendant again after that talk. Complainant #1 stated he told his parents everything that had happened with the Defendant.

On January 22, 2026, Complainant #2 told Affiant that he was little when he first saw the Defendant. Complainant #2 stated one day they were baking cookies, and he recalls putting the cookies in the oven when the Defendant called him over to show Complainant #2 something on her phone. Complainant #2 stated he thought she was going to show him a recipe, but she showed him a picture of her fully naked. Complainant #2 stated that the second incident happened when he was 12 years old and the Defendant asked him to go cuddle with her. Complainant #2 stated the Defendant started touching him and he hated how she did that. Complainant #2 stated the Defendant touched his penis. Complainant #2 stated the Defendant would touch his penis, at first over his pants and then under his pants. Complainant #2 stated the Defendant did it with him when he was 13 years old, but that he didn't know because he was asleep. Complainant #2 stated that he learned about it from his parents because he got told they saw what happened in the cameras and got told that the Defendant gave him the papilloma virus. Complainant #2 stated that the last time it happened, the Defendant came into his room, and undressed herself in front of Complainant #2. Complainant #2 stated he was playing video games and the Defendant asked him to rub her back because it hurt. Complainant #2 stated he did not want to do nothing, but the Defendant laid on his bed. Complainant #2 stated his penis touched inside the Defendant. Complainant #2 stated that he thought it was just happening with him, but he was told that she was doing the same thing with his dad and his brother. Complainant #2 stated all of this affected him too much and he became a high school dropout and has not been able to bring himself to go back to school and finish.

On February 3, 2026, Affiant observed a forensic interview that Complainant #1 had at the Forensic Center of Excellence with Adult Forensic Interviewer M.M. Complainant #1 agreed to tell the truth. Complainant #1 stated that he was there because a woman named Hailey molested him and his brother, Complainant #2. Complainant #1 stated they had forgotten about the whole incident, but that when he came back from Ecuador November 2025, he learned that his dad, J.C.G. was with the Defendant so he wanted to continue the investigation. Complainant #1 stated that initially his mother, M.B., wanted to press charges, but his dad, J.C.G., convinced her not to. Complainant #1 stated that his dad told him that if the Defendant was convicted, that this would be on his record and that the Complainant #1 would not be able to get hired in the future. Complainant #1 stated they got molested by the Defendant and it started one week in 7th grade when he had to memorize script for theater class. Complainant stated he asked the Defendant for help memorizing lines and he fell asleep. Complainant stated when he woke up, the Defendant asked him to massage her. Complainant #1 stated he was spooning the Defendant. Complainant stated he started to massage the Defendant's thighs and she would move and move until his hand landed on the Defendant's vaginal area and the Defendant stopped moving as if saying that is where she wanted his hand. Complainant #1 stated the second time it happened, he went under her underwear and the Defendant would make noises and moan. Complainant #1 stated the Defendant would always tell the Complainant #1 to go to her room when he got sleepy. Complainant #1 stated the Defendant would put the Complainant's hand on her boob under her shirt. Complainant #1 stated every time, the Defendant would move around until the Defendant's hand ended up on her vaginal area, that he would put his finger inside the Defendant's vagina, that his hand would be wet and soggy. Complainant #1 stated it smelled nasty, that he would go back to his room or sleep with the Defendant the rest of the night. Complainant #1 stated that if he slept with the Defendant, he would wake up in the morning and wash his hands. Complainant #1 stated his dad, J.C.G. would go upstairs, see him in the guest room with the Defendant, and tell him that he was not supposed to be there. Complainant #1 stated that he and his friend would see the Defendant spend a lot of time in his dad's J.C.G.'s room and his dad made a comment stating "dang, she got the whole family," as a joke. Complainant #1 stated the last time it happened, he knocked on the door and the Defendant let him in and they began doing the same thing they usually did, but that time, Complainant #1 grabbed the Defendant's arm and put it on his private. Complainant #1 stated the Defendant started to move it around and Complainant #1 orgasmed. Complainant #1 stated he touched the Defendant's butt, thighs, boob, and vagina. Complainant #1 stated another thing that the Defendant did was undress in front of him.

Complainant #1 stated the Defendant is a special ed teacher. Complainant #1 stated that one day, 8th grade summertime, his parents confronted both him and his brother about what was happening. Complainant #1 stated his mother was petrified, but his father was chilling. Complainant #1 stated he moved to Ecuador and even though his mother wanted to press charges, his father did not want to. Complainant #1 stated that when he touched the Defendant; the Defendant would grab his arm and put it on her private, that it all would be silent and her eyes would be closed pretending to be asleep, but that he knew she was not sleeping because after she was finished, she would get up and clean herself in the bathroom. Complainant #1 stated his dad is going to Mexico and taking the Defendant with him. Complainant #1 described the Defendant as blonde, big, chunky, tall, about 5'10", with blue or green yes, Caucasian, and pale skin color, mid-thirties.

On February 3, 2026, Affiant observed a forensic interview that Complainant #2 had at the Forensic Center of Excellence with Adult Forensic Interviewer M.M. Complainant #2 agreed to tell the truth. Complainant #2 identified Hailey, the Defendant, as his babysitter. Complainant #2 stated the incidents with the Defendant started when he was 13 or 14 years old. Complainant #2 stated he does not

remember his age with the first grooming incident. Complainant #2 stated the Defendant would babysit him daily at the old house. Complainant #2 stated that the Defendant would always tell him to go sleep with her. Complainant #2 stated the Defendant would act like she was asleep and touch his private parts. Complainant #2 stated the second incident is when the Defendant raped him. Complainant #2 stated the Defendant told him to go sleep with him so nothing would happen to him and he told her "Ok, no problem, sure." Complainant #2 stated the Defendant began to touch him, got his dick to stand up, and forced herself on him. Complainant #2 stated that he didn't understand what happened, but from then, he got traumatized. Complainant #2 stated he had bad influences at school because when he would tell his friends, his friends would tell him that what was happening with the Defendant was really good. Complainant #2 stated he was a little kid, would ask the Defendant for a hug, and she would say sure, he would put his hand down to her butt, and she let it happen. Complainant #2 stated the Defendant took off her bra and let him look at her boobs. Complainant #2 stated he thought that was amazing, but looking back, he stated he didn't know it was wrong. Complainant #2 stated the Defendant would tell him her back hurt and she would let him touch her boobs. Complainant #2 stated the Defendant kept doing it so much and at age 16 he started liking it. Complainant #2 stated they then moved to the new house and it was there that the Defendant would leave her door open, he would sneak in, go inside and touch the Defendant's butt. Complainant #2 stated the Defendant would act like she was asleep, but he didn't understand because she would wake up and go use the restroom. Complainant #2 stated the last incident happened when he was in high school. Complainant #2 stated that when he was 16 and a half, the Defendant let him have sex with her. Complainant #2 stated they both were acting asleep, that the Defendant let him touch her, one thing led to another and he was on top of her. Complainant #2 stated he would touch her boobs, the Defendant would groan, and he finished inside the Defendant. Complainant #2 stated the second time it happened, it happened in his room, he opened his eyes and he saw the Defendant on top of him. Complainant #2 stated he just let it happen. Complainant #2 stated the Defendant was having sex with him, that she put his dick inside her vagina. Complainant #2 stated the Defendant was sustaining her body so she didn't fall on him and that he saw her fully naked and that her boobs were in his face. Complainant #2 stated he was scared and stiff thinking how could he get out of this. Complainant #2 stated he was scared the Defendant was doing this to him. Complainant #2 stated he probably finished like a man finishes inside of a woman. Complainant #2 stated the sex happened only two times.

Complainant #2 stated his dad showed him the video on his dad's phone of him having sex with the Defendant. Complainant #2 stated his dad, J.C.G. would also go into the Defendant's room and have sex with her. Complainant #2 stated the people he told was his girlfriend, V.V. and the first adult was his dad, J.C.G. Complainant #2 stated his mother was in shock and his dad chose the Defendant over protecting him and his brother. Complainant #2 stated the Defendant had a virus that got transmitted to him. Complainant #2 stated the touching happened about twice a week, that he started going to websites, and he got addicted to porn. Complainant #2 stated his clothes were on and he remembers an odor coming from his private part that stink when she was not in the house any longer. Complainant #2 described the Defendant as blonde, blue eyes, big butt, and age 30 something.

On January 30, 2026, Affiant reviewed the Complainant's medical records from Bluefish Pediatrics, documented on January 25, 2023 by PCP Jennifer D. Penland and Katherine Lusk, MD. The records show the following notes regarding Complainant #1: "mom wants to test for hpv, pt utd on hpv imm, checked in by Alondra, brought in by mom, per mom, dad installed indoor cameras in house 1 month ago, over wknd, mom's longtime friend/boy's fmr 32 yo female babysitter staying w fam. On camera, parents saw footage of pt coming out of guest room where fmr babysitter was staying at 1am. When confronted, pt admitted to sexual contact w her starting 2yr ago and has been ongoing. Per pt, did not engage in intercourse w pt (no vaginal or anal penetration), denies oral sex. Pt states was hands on genitals. Denies penile dc, genital lesions." The records show the following notes regarding Complainant #2: "mom wants to test for hpv, pt utd on hpv imm, checked in by Alondra, brought in by mom, per mom and separate conversation w pt to confirm: parents found out mom's friend/pt's fmr babysitter had vaginal intercourse X2 w pt 2 yr ago. Babysitter 32 yo currently. Pt tried 3rf time but she declined per mom. Denies penile dc, pain, genital or oral lesions."

On September 25, 2025, I contacted the Defendant and she agreed to speak with Affiant for a voluntary interview on October 4, 2025. The Defendant did not attend the voluntary interview. Affiant showed M.B. a photo of the Defendant's Texas Driver's License and M.B. confirmed the photo was the Defendant, Hailey Hedspeth.



Based upon the Complainant #1's date of birth, he would have been 13 years old on October 1, 2020 and the Defendant would have been 29 years old. When the abuse stopped, Complainant was 15 years old and the Defendant was 30 years old.

Based on the Complainant #2's date of birth, he would have been 11 years old on March 20, 2017 and the Defendant would have been 25 years old and was 14 when the abuse stopped. When the abuse stopped, Complainant #2 was 31 years old.


