Complaint for violation of Title 21 United States Code §§ 841(a)(1) and 844(a)

COMPLAINANT'S STATEMENT OF FACTS CONSTITUTING THE OFFENSE OR VIOLATION:

Count 1

On or about October 26, 2009, at or near Naco, in District of Arizona, **Luis Francisco Corona-Montana**, did knowingly and intentionally possess with intent to distribute less than 50 kilograms of marijuana, that is, approximately 4.31 kilograms of marijuana, a Schedule I controlled substance; in violation of Title 21, United States Code, Sections 841(a)(1) and 841(b)(1)(D).

Count 2

On or about October 26, 2009, at or near Naco, in District of Arizona, **Luis Francisco Corona-Montana**, did knowingly and intentionally possess 4.31 kilograms of marijuana, a Schedule I controlled substance; in violation of Title 21, United States Code, Section 844(a).

BASIS OF COMPLAINANT'S CHARGE AGAINST THE ACCUSED:

On October 26, 2009, an individual was observed illegally crossing the pedestrian bridge east of the Naco, Arizona Port of Entry. Agents responded to the area and observed the individual remove his jacket and attempt to throw the jacket over the pedestrian bridge. The agent apprehended the individual as he attempted to climb back over the fence into Mexico. The jacket was located and found to contain approximately 4.31 kilograms of marijuana. The individual was identified as **Luis Francisco Corona-Montana**. **Corona-Montana** admitted he had been paid \$20.00 to wear the jacket while crossing the fence and that he was to turn the jacket over to an unknown individual.
