Court finds that the evidence and Defendant's plea substantiates the Defendant's guilt of the offense beyond a reasonable doubt as charged in the indictment. Adjudication of guilt Deferred and Defendant placed on probation for 10 years, subject to terms and conditions of probation served on Defendant. Serve 30 days in the Collin Count Jail as T and C which is probated. No direct communication with victim or victim's family. Ch. 62 lifetime sex offender registration. Sex offender caseload and conditions. Mandatory protective order for all victims. Agreed protective order for victim. defendant may have his phone back if he wipes device. State waives ELM condition of Sex offender caseload. State to refuse indecency and continuos cases. RUA's. Defendant forfeits teaching license. No contact with minors except biological children. Defendant can keep address..</i>
