FELONY PROBABLE CAUSE AFFIDAVIT

In the Name and by the authority of the State of Texas: BEFORE ME, the undersigned authority on this day personally appeared the undersigned affiant, who after being by me duly sworn on oath, deposes and says that he or she has good reason to believe and does believe, that heretofore, to wit: on or about between March 1, 2026 and June 3, 2026, and anterior to making and filing this complaint, in the County of Collin and state of Texas NEU, ZACHARY CHRISTIAN W/M 04/29/1994 5'09" 180 lbs. Brown Hair, Blue Eyes, Texas DL [redacted] did then and there commit IMPROPER RELATIONSHIP BETWEEN EDUCATOR AND STUDENT, a criminal offense against the laws of the State of Texas. The defendant then and there, engaged in conduct described by Section 33.021, with a student enrolled in a public or secondary school at with the defenant worked, regardless of the age of the victim in violation of Texas. P.C. 21.12(3), a second degree felony.

Affiant Det. Chris Meehan, is employed by the Wylie Police Department, Collin County Texas, assigned as a Criminal Investigator. Affiant's belief is based on the following facts:

On June 4, 2026, Wylie PD arrested Zachary Christian Neu W/M 04/29/1994 for Solicitation of Prostitution Under the age of 18 years old resulting from an investigation under Wylie PD case number [redacted]. In that case, Mr. Neu solicited a 17-year old female shortly after she graduated and agreed to purchase her alcohol and give her money to buy lingerie so she would come to his house and engage in sexual contact with him. At the time, Mr. Neu was the Assistant Principal at Wylie East High School where the student just graduated from.

After his arrest, a press release was done by the Wylie Police Department and Wylie ISD. On June 4, 2026 at approximately 5:52 pm, I received a call from [redacted] regarding the press release. [redacted] stated that she saw the press release, and asked her daughter about it. Her daughter, hereinafter referred to as [redacted] attends Wylie East High School and will be a Senior next year.

[redacted] stated her daughter started crying and was visibly upset. When asked what was wrong, [redacted] told her that in March 2026, Mr. Neu began messaging her on TikTok, then they began texting. She stated during the communication, Mr. Neu solicited her and they began sexting. She stated Mr. Neu sent her photos of himself in his underwear, and she sent him photos of her in her bra and panties. They continued the online relationship between March and May, 2026.

[redacted] stated that on May 13, 2026 after she got off work, she agreed to meet Mr. Neu in the parking lot of L.A. Fitness located at 7720 S. State Highway 78 in Sachse, Texas. She stated they parked on the side towards the back of the building and got out of their cars. She stated that while there, Mr. Neu kissed her and grabbed her buttocks and squeezed her real hard in a sexual manner. She stated it hurt but she didn't say anything.

[redacted] stated that after they kissed, he kind of backed off like he was nervous about it and nothing else physical happened. [redacted] stated that Mr. Neu has continued to communicate with her as recently as yesterday. [redacted] was scared and upset at reporting this, but her mother encouraged her to prevent it from happening to other students.

[redacted] provided me her phone number. At the time of Mr. Neu's arrest, his cell phone was seized per a search warrant for a forensic exam. I reviewed his cell phone data and put [redacted] phone number in the search feature, and located both TikTok and regular text messages between the two of them corroborating the victim's statements on his phone.

Based on the fact that Mr. Neu was the Vice Principal of the school where [redacted] attends, that he engaged in conduct consistent with PC 33.021 (online solicitation) with the victim regardless of her age, Mr. Neu committed the offense of Improper Relationship between Educator and Student. This is in violation of Texas Penal Code 21.12(3), a second degree felony.
