FELONY PROBABLE CAUSE AFFIDAVIT

In the Name and by the authority of the State of Texas: **BEFORE ME**, the undersigned authority on this day personally appeared the undersigned affiant, who after being by me duly sworn on oath, deposes and says that he or she has good reason to believe and does believe, that heretofore, to wit: on or about **between May 27, 2026 and June 2, 2026**, and anterior to making and filing this complaint, in the County of Collin and state of Texas **NEU, ZACHARY CHRISTIAN W/M 04/29/1994 5'09" 180 lbs. Brown Hair, Blue Eyes, Texas DL [REDACTED]** did then and there commit **SOLICITATION OF PROSTITUTION**, a criminal offense against the laws of the State of Texas. The defendant then and there, knowingly offers or agrees to pay a fee to another person for the purpose of engaging in sexual conduct with that person or another and that person was under the age of 18 years old in violation of Texas. P.C. 43.021(b)(2)(A), a second degree felony.

Affiant **Det. Chris Meehan**, is employed by the Wylie Police Department, Collin County Texas, assigned as a **Criminal Investigator**. Affiant's belief is based on the following facts:

Affiant learned the following information from Wylie Police Officer Stewart, Officer Serrato, by reviewing the police report #26019554 and by personal investigation.

On May 27, 2026, at approximately 1140 hours, Wylie Police Officer Serrato was performing duties as a school resource officer at Wylie East High School, located at 3000 Wylie East Drive in Wylie, Collin County, TX 75098. Officer Serrato was contacted via phone by WEHS Coach Ontario Davis, in reference to a recent graduate reporting to him that another Wylie East staff member was sending inappropriate messages to her.

Davis advised he was contacted by [REDACTED] a 17-year-old 2026 Wylie East High School graduate, who reported to him that Assistant Principal Zachery Neu had sent her inappropriate messages asking to meet up with her and for Neu and [REDACTED] to shower together. Davis advised he told [REDACTED] to report the messages to the police, but wanted to make an officer aware of the incident in case the report had not been made. Davis provided the messages sent to him by [REDACTED]

On the messages, [REDACTED] tells Davis that not even 20 mins after she walked out of the building from graduating, Neu began messaging her. [REDACTED] then states that Neu mentions meeting up and showering together. Davis then tells [REDACTED] to report the messages to the police, to which [REDACTED] replied she would.

Wylie Police Officer Stewart was working the front desk at Wylie PD when [REDACTED] identified as [REDACTED] came into the police department to report the incident. [REDACTED] had [REDACTED] phone and emailed the screenshots of the messages between [REDACTED] and Mr. Neu to Officer Stewart.

Officer Stewart contacted me regarding this incident. [REDACTED] had left after making the initial report, and I advised we would need [REDACTED] phone to do a forensic download on it. He contacted [REDACTED] and she returned to the police department.

I spoke to [REDACTED] and she confirmed what [REDACTED] had told Coach Davis. She stated that after graduation, [REDACTED] received a notification that Zachary Neu was following her on Instagram, and shortly after that he sent her a private message. [REDACTED] signed a consent to search [REDACTED] phone, and provided her Snapchat and Instagram log-in credentials.

[REDACTED] stated that after messaging [REDACTED] on Instagram, he told her to message him on Snapchat and provided his snapchat username of "zach.n94". She stated he then messaged her inappropriately on Snapchat.

[REDACTED] also signed a Consent to Assume Online Identity form, and authorized me to take over [REDACTED] Snapchat and Instagram accounts and assume her identity to continue communicating with Mr. Neu. I logged on to [REDACTED] Snapchat account using an undercover cell phone, and obtained a forensic image of her cell phone.

I identified [REDACTED] snapchat username as [REDACTED] and sent preservation letters to Snapchat for both accounts. I reviewed their initial communication on Instagram. Mr. Neu tells her she was his favorite student. He talks about working out and she said he looked great. He said she should see him after he lifts weights, and told her they would have to keep that a secret. She said she would and he said "Good, figured I could trust you."

Mr. Neu then told her to add him on Snapchat. I reviewed those messages, and in the messages, Mr. Neu stated he was at school in his office making the master schedule for the math department and engaged in general conversation. He asked her to "come save him" and she stated he would get in trouble if she came and saved him. He stated "what they don't know [won't] hurt anyone. We can be sneaky." [REDACTED] then stated "Hey just in case yk im not 18 yet right?" He replied "Oh no I did not..didn't realize you were a young graduate...Doesn't change how I feel about you. Does it change things for you or like does it make you feel weird?"

Mr. Neu asks what her birthday is, and she replied [REDACTED] She asks "what about your wife?" and he replied "...we are rocky and going through the motions sense we have a 2 and a half year old." He asks "You still want to continue what we have started?" and she stated she is fine with that. He then sends her two pictures of him without a shirt on. She commented on the pictures and he said there are more to come. She refers to him as Mr. Neu, and he stated that was "kinda hot."

Mr. Neu told [redacted] "I like someone [redacted] knows what they want. Also, I hope you don't [redacted] and, I don't plan on waiting til your birthday to see you." He stated he has the house to himself on some weekends, and that she could come over to his house but that they have to be sneaky and smart about it. He stated he has a pool and wanted to meet her before then so he could give her a hug.

At this point, it appeared he was grooming her. I changed the password on [redacted] Snapchat account to prevent her from accessing it. I logged into her account on an undercover cell phone and continued communicating with Mr. Neu. During the chats, he stated he wanted to meet her and they could go for a walk on the trails. He sent a location of a park near her house they could go to. He wanted to meet her on Friday night (May 29th, 2026). He said he wanted to kiss her.

Mr. Neu stated he is impatient, and mainly about things he wants. When asked what he wants, he replied "you". He stated he would love to experience a wild time with her. In the chats, he again asked about taking a shower together and said "most likely be jaw dropped seeing you.....cause you are quite attractive."

The chats continued on May 28th, 29th, 30th and 31st. Mr. Neu asked her if she was a little wild, and said he would live to experience a wild time with her. The conversation went back to taking the shower together, and he stated "you all dripping wet. What could be better". I responded "and kiss" and he stated "of course" and that they can see where that leads them too and he didn't want to rush things. He asked what she would want to happen, and I said I just can't get pregnant and he stated he did not want that either and didn't want any more kids.

The conversation discussed them having sex. He stated his wife and daughter were going out of town next weekend, and asked if she wanted to come over, He provided his phone number of [redacted]. He stated she could spend the night at his house on Friday. Mr. Neu asked if she wanted anything to drink and stated that he only has Coors but can buy her whatever she wants. I told him Fireball is good, and he stated "I got you".

We then switched to texting, and I used Callyo to communicate with him. They continued discussing having sex, and I advised him that she was a virgin. He stated he would go slow and teach her and do whatever she was comfortable with.

During the texts, Mr. Neu agreed to pay her \$20 cash to purchase some lingerie to wear when she goes to his house and they have sex. He also sent numerous selfie pictures and it was confirmed that he is Zachary Neu. The phone number he communicated on shows to belong to Zachary Neu.

Based on the fact that he agreed to purchase her alcohol and give her money to purchase lingerie so she could come over and engage in sexual intercourse with him, he committed the offense of Solicitation of Prostitution (Under 18 years of age)..

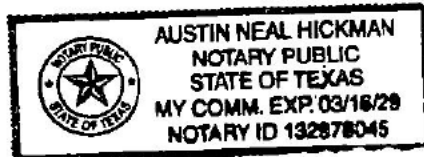
