INDICTMENT

The Grand Jury Charges:

Count One

Possession of Child Pornography Involving a Prepubescent Minor
(Violation of 18 U.S.C. §§ 2252A(a)(5)(B) and 2252A(b)(2))

On or about January 8, 2026, in the Abilene Division of the Northern District of Texas, and elsewhere, **Lance Carl Mosley**, defendant, did knowingly possess materials, which contained at least one image of child pornography, as defined in Title 18, United States Code, Section 2256(8)(A), that involved a prepubescent minor and a minor who had not attained 12 years of age, and which was shipped and transported using any means and facility of interstate and foreign commerce and in and affecting interstate and foreign commerce by any means, including by computer, and that was produced using materials that have been mailed, and shipped and transported in and affecting interstate and foreign commerce by any means, including by computer.

Specifically, **Mosley**, using his iPhone 16 Max Pro, Serial #FXF45R6X1G; his iPad, Serial Number DMPRD2UWGXXQ8; and his iPad, Serial Number FX6CVM9XCV, possessed the following visual depictions of minors engaged in sexually explicit conduct as defined in 18 U.S.C. § 2256:

iPad, Serial Number FX6CVM9XCV	...62efc21a	An image that depicts a nude six-to-eight-year-old male child lying down with his erect penis exposed.
iPad, Serial Number DMPRD2UWGXXQ8	...116ddb	An image that depicts a ten-to-twelve-year-old nude male child holding his penis.
iPhone 16 Max Pro	...2977a78c	An image that depicts a nude six-to-eight-year-old male child lying down with his erect penis exposed.

In violation of Title 18, United States Code, Sections 2252A(a)(5)(B) and 2252A(b)(2).

Forfeiture Notice
(18 U.S.C. § 2253)

Upon conviction of the offense alleged in this indictment and pursuant to 18 U.S.C. § 2253, defendant **Lance Carl Mosley** shall forfeit to the United States of America: (a) any visual depiction described in Section 2251, 2251A, 2252, 2252A, 2252B, or 2260 of Chapter 110, and any book, magazine, periodical, film, videotape, or other matter which contains any such visual depiction, which was produced, transported, mailed, shipped, or received in violation of Chapter 110; (b) any property, real or personal, constituting or traceable to gross profits or other proceeds obtained from the offense alleged in the Indictment; and (c) any property, real or personal, used or intended to be used to commit or to promote the commission of the offense alleged in the Indictment, and any property traceable to such property.

The above-referenced property subject to forfeiture includes but is not limited to a:

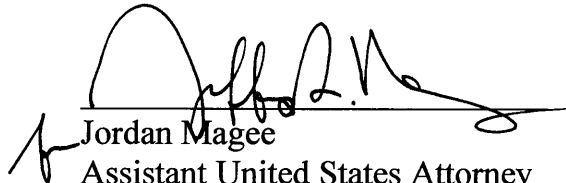

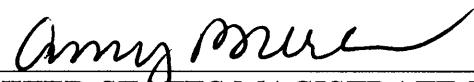
