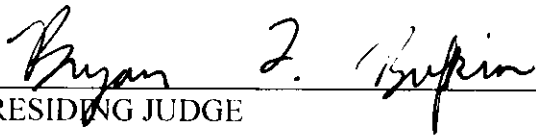

IT IS THEREFORE, ORDERED, ADJUDGED, AND DECREED that Defendants' Plea

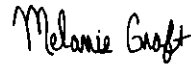
to the Jurisdiction is hereby GRANTED, and Plaintiffs' claims are dismissed with prejudice as to refiling.

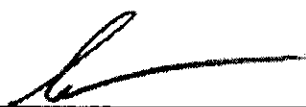
