My name is Det. Michael Maeker #1920 and I am a certified peace officer for the Plano Police Department, Plano, Texas. I hereby state upon my oath that I have reason to believe and do believe that heretofore, and before the making and filing of this Complaint, the following:

On or about the 15 day of May, 2026, in Collin County, Texas, the defendant, **Paul Edward Campbell**, did then and there commit the offense of **Indecency with a Child Sexual Contact, TX PC 22.11(d), a 2nd Degree Felony** against the laws of the State.

My probable cause for said belief and accusation is as follows:

Affiant, Detective Michael Maeker #1920, is a certified Master Peace Officer employed by the City of Plano Police Department for over 8 years. Affiant is currently assigned as a Detective with the Special Victim's Unit, and has had the opportunity to work and assist in investigating a variety of criminal offenses. Previous criminal investigations conducted by Affiant resulted in successful prosecutions of the offender. Previous criminal investigations conducted by Affiant also found the alleged offender did not commit a criminal act. In addition, Affiant has attended many training courses related to the investigation of offenses involving digital forensic evidence and other types of evidence.

The Affiant, while assigned to the Special Victim's Unit of Plano PD was assigned a case #26-132455 on 7-06-26. The original report was taken by Ofc. C. Wilson #2047 on 7/04/2026. The report was in reference to Indecency with a Child and was reported to have occurred at Brinker Elementary School located at 3800 Clark Pkwy. Plano, Collin County, Texas during the 2025-2026 school year. The Affiant obtained the following information from the officer's original report, witness interviews, and victim interviews. Affiant believes the following information to be true.

According to Ofc. C. Wilson's report, on 07/04/2026 at approximately 1607hrs, she was dispatched to [REDACTED] in Plano, Texas. The caller was reporting that their daughter Victim 1 had been sexually assaulted by her teacher. The caller was identified as the father of Victim 1, fully identified in the case report. The father of Victim 1 reported that on 7/04/2026, his daughter (Victim 1) had told her sisters that that her 2nd grade teacher had touched her private parts. The girls then reported it to their father. The suspect was identified at that time only as Brinker Elementary School 2nd Grade teacher Paul Campbell. This subject was later identified through PISD at Paul Edward Campbell, WM, DOB 10/07/1961. This subject will be referred to as Campbell for the

remainder of this Affidavit. Victim 1 reported that Campbell would call girls over behind his desk and touch their private parts.

Campbell was arrested on 7/08/2026 pursuant to arrest warrant #AUX-07072026-50 signed by Judge Dan Wilson on 7/07/2026. that warrant was for Sex Abuse of a Child Continuous Victim under 14, PC 21.21(b). There was a press release of Campbell's arrest.

On 7/14/2026, a subject identified as "Victim 3" (identified fully in the report) was brought for a forensic interview at the Children's Advocacy Center of Plano. Victim 3's parents (identified in the report) had been notified of Campbell's arrest and spoke to their daughter about the situation. It was reported that Victim 3 outcried to her parents on 7/10/2026. Victim 3 reported that she was in Campbell's class for the 2025-2026 school year. Victim 3 outcried that Campbell used his hand to touch and rub her, over the clothing, on the part she uses to pee. This was clarified to be the vagina during the interview. Victim 3 said this occurred in Campbell's classroom at his desk. Victim 3 said this made her uncomfortable and Campbell was not supposed to do this. Victim 3 said this happened about 4 times during the school year.

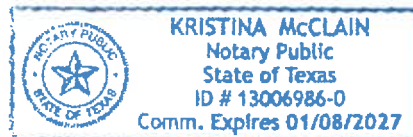
Based on the totality of the circumstances the Affiant has reason to believe, and does believe, that on or about the date of 05/15/2026, Paul Edward Campbell, WM, DOB 10/07/1961 did commit the offense of Indecency with a Child Sexual Contact, TX PC 22.11(d), a 2nd Degree Felony; A person commits an offense if, with a child younger than 17 years of age, whether the child is of the same or opposite sex and regardless of whether the person knows the age of the child at the time of the offense, the person: engages in sexual contact with the child or causes the child to engage in sexual contact. This occurred when Campbell, with the intent to arouse or gratify, touched Victim 3 in a sexual manner on her vagina, over the clothes.

On 7/06/2026, The Affiant contacted CPS and set up a Forensic Interview for Victim 1. Victim 1 was interviewed at the Children's Advocacy Center of Plano on 7/06/26. Victim 1 outcried that, while she was a student in Campbell's 2nd grade class in the fall 2025 and spring 2026 school year, she would go to his desk to ask questions and he would use his hand to touch her between the legs and rub her "pee pee place". This was confirmed during the interview to mean her vagina. Victim 1 reported that this happened on several occasions and that Campbell would answer her question but rub her vagina with his hand while he answered. Campbell would be sitting down at his desk and she would be standing. Victim 1 believed she observed this happening to other females in the class. Victim 1 spoke to Victim 2 about this while school's spring semester was still ongoing and Victim 2 confirmed that Campbell had touched her vagina over the clothes as well.

Campbell was arrested on 7/08/2026 pursuant to arrest warrant #AUX-07072026-50 signed by Judge Dan Wilson on 7/07/2026. that warrant was for Sex Abuse of a Child Continuous Victim under 14, PC 21.21(b). There was a press release of Campbell's arrest.

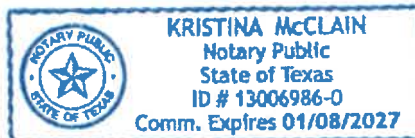

Victim 4 stated that Campbell touched her at least two times while she was in 2nd grade.

At first [REDACTED] did not say anything, but when asked if he touched her [REDACTED] cried and told her mother that he had touched her private part and that it happened more than once.

On 7/07/2026, [REDACTED] was forensically interviewed at the Plano Children's Advocacy Center. [REDACTED] outcried independently that, when she when to Campbell's desk that he would use one hand to touch her "private place" over her clothing. This was clarified to be [REDACTED]'s vagina during the interview. [REDACTED] reported that this began occurring within the first weeks of the Fall 2025 semester and occurred up until the last day of school in Spring 2026. [REDACTED] reported Campbell would answer what question she asked and would rub her vagina in a side-to-side motion with his hand. [REDACTED] reported she observed Campbell do this to two other girls in class, but that she knew it had happened to her friend [REDACTED] because they had talked about it. [REDACTED] noted that they did not see Campbell do it to any of the boys in class. [REDACTED] reported that that Campbell touched her many times and that he would rub her thigh, hip, butt cheek, and vagina. [REDACTED] said this occurred during class and was at Campbell's desk or the "teacher table" and that it occurred at recess. [REDACTED] said during recess another teacher asked her to go tell Campbell something and so she went to see him. [REDACTED] outcried that Campbell touched her vagina and butt cheek. He rubbed her vagina over the clothes and put his other hand in his front pants pockets and was playing with something. [REDACTED] demonstrated this during the interview. It appeared that Campbell may have been touching his genital area though his pocket.

Based on the totality of the circumstances the Affiant has reason to believe, and does believe, that on or about the date of 05/15/2026, Paul Edward Campbell, WM, DOB 10/07/1961 did commit the offense of Sex Abuse of Child Continuous: Victim Under 14, PC 21.02(b), 1st Degree Felony; A person commits an offense if, during a period that is 30 or more days in duration, the person commits two or more acts of sexual abuse, regardless of whether the acts of sexual abuse are committed against one or more victims; and, at the time of the commission of each of the acts of sexual abuse, the actor is 17 years of age or older and the victim is: a child younger than 14 years of age, regardless of whether the actor knows the age of the victim at the time of the offense. This occurred when Campbell assaulted at least two of his second-grade female students by rubbing their vaginas over their clothing. This was reported to have occurred multiple times throughout the school year. This was two or more victims and over at least a 30 day time frame.

Affiant request that a warrant be issued for Paul Edward Campbell's arrest for Sex Abuse of Child Continuous: Victim Under 14, PC 21.02(b), 1st Degree Felony.
